ABOUT GIAN:

"TRANSNATIONAL COMMERCIAL LAW" COURSE OVERVIEW

Transnational Commercial Law is born out of conventions, treaties, domestic legislations and commercial customs or usages. This body of law governs international commercial transactions and it is applied to a number of legal systems. Transnational Commercial Law has to be distinguished from International Economic Law since the former focuses on private law in transactions, especially cross-border transactions, whereas the latter concerns with dealings between states. It is important to be aware of the legal principles that govern transnational commerce as such knowledge is vital for any legal professional who wishes to excel in the face of challenges of legal practice in a globalised world, where many of them will be dealing with cross-border transactions on a daily basis.

The program contents provide an introduction to three important areas of transnational commercial law: the CISG, Carriage of Goods and International Commercial Law Practice. More generally, the course aims to orient participants to sales law and arbitral aspects of international business law practice. The specific areas covered in the course, while not exhaustive, are sufficient to provide participants with an introduction to international commercial law. Additionally, since the course materials include numerous cases from different jurisdictions, arbitral award decisions and hypothetical discussion problems, the program contents also aim at familiarizing students with case law analysis from various judicial bodies and jurisdictions outside India.

DR. PETER J. MAZZACANO

Peter J. Mazzacano, BA, MLA, MBA, LL.M, PhD, is the Founder and Editor of *CISG Canada*, which is dedicated to Canadian jurisprudence on the UN International Sale of Goods Convention (CISG).

He has taught numerous law courses at various universities and colleges over the years. These include *Legal Aspects of International Business* at Ryerson University, and *Canadian Business Law* at York University, in Toronto.



He served as a Visiting Professor and Adjunct Professor at Osgoode Hall Law School, where he taught *Legal Process, Civil Procedure, Graduate Legal Research and Writing*, and *International Dispute Resolution*. During that time, from 2006 to 2012, Peter also co-coached Osgoode's Vis Moot Team. Recently, he served as an adjunct faculty member at the University of Guelph and Sheridan College where he taught a number of business law courses.

Peter is currently based out of Toronto, Canada, and serves as an Associate Academic in Law at the University of Derby (UK), where he tutors graduate law students in a variety of commercial law subjects, as well as supervising LL.M dissertations.

Peter continues to research and publish in the area of the CISG. He has numerous publications in international law journals on topics related to the CISG and international commercial law generally. In 2014 his book was published, *Exemptions for the Non-Performance of Contractual Obligations in CISG Article 79: The Quest for Uniformity in International Sales Law*, (Cambridge, UK: Intersentia Publishing).

TEACHING METHOD

The teaching method will be primarily via lecture. However, students will be expected to answer questions on the assigned readings and to engage in a discussion of the course material. In particular, the assigned readings will include court decisions, arbitral awards, and hypothetical or practical problems that the students will be expected to analyse and discuss in class.

CREDITS

The course is credit based. Candidates will earn **ONE Credit** upon successful completion of this course, as per MHRD Guidelines on GIAN. Participants will have to identify a compatible course from their institution to be able to successfully transfer the credits. They will have to make arrangements to process the applications in their respective institutions.

The maximum number of participants will be limited to fifty only.

As per GIAN Guidelines, candidates of the host institution can fill a maximum 50% of the total seats.

In the event that the number of applications exceed the number of available seats, selection criteria identified by the University shall be adopted to shortlist the participants.

- Law students at all levels (BA LLB/LLB/LLM/JD/JSD/PhD);
- Faculty from law schools, universities, colleges and institutions of higher education;
- Lawyers, In-house counsels;
- Professionals from industry involved in transnational commercial law practice.

FEES

The participation fees for taking the course is as follows:

A. Participants from outside India: US \$250/-

B. Professionals/Lawyers/Non-Academics: Rs. 10,000/-

C. Faculty/Students from academic institutions requiring accommodation (excluding food): Rs. 6,000/-

D. Faculty/Students from academic institutions not requiring accommodation: Rs. 3,000/-

E. Faculty and Students from National Law University, Delhi: No Fee

The above fee includes all instructional materials, classes and internet facility.

The participants will be required to **pay separately** for food/meals.

Accommodation may be provided within the University campus only in case of availability, which will be in limited numbers. Preference shall be given to faculty members and outstation candidates.


