THE CONTEXT

The occurrence of water conflicts of different types and scales have been on the rise and will continue to be so in the future. As a society we have not been able to deal with water conflicts in a socially and environmentally just manner. The legal framework is one of the several dimensions that need further consideration to better prevent and solve conflicts. Existing water law is often not well known by lawyers, partly because it is a complex area of law, finding its sources in a variety of places and is often not seen as a coherent body of regulation, as confirmed by the fact that surface and groundwater are still governed by different appropriation principles. Another problem is that laws concerned with water conflicts, the focus has been only on conflict resolution, rather than conflict prevention. Thus, it is the lack of clear rules concerning water allocation that explains why such conflicts often end up in court.

Lawyers and judges play a big role in preventing conflicts and solving them in a coherent manner. They are not sufficiently sensitised to the complex nature of water law, the links between water law and other branches of law and the need to look at water in its multiple dimensions. Also, the present legal regime does not seem to be informed by the bio-physical and socio-cultural peculiarities of water as a resource.

Keeping this in mind the Forum for Policy Dialogue on Water Conflicts in India, National Law University Delhi, the National Green Tribunal and Environmental Law Research Society have devised a training programme to foster and strengthen a community of people working in the water sector or engaging with water as part of their work in other fields, who are aware of the complexity of issues in water law and are willing to apply principles and concepts that exist in the legal framework. It is in particular critical to ensure that water is not considered only or mainly through environmental law or property rights but as a full fledged and comprehensive field in its own right. This training programme thus seeks to foster a broader recognition of the central importance of water law as a field requiring separate consideration in view of its critical role in water conflict prevention and resolution.

CONTENT

The following themes will be covered in the training programme:

- The biophysical and socio-cultural peculiarities of water
- Water Rights: Land based rights, tradable rights, statutory rights, constitutional, fundamental and common law right to water
- Inter-state and transboundary conflicts
- Water Laws and their practice in courts
- Law, Water & Environment: Engagement with the NGT
- Laws related to irrigation, dams and displacement
- Groundwater and the legal regime
- Inter-sectoral water use, allocation and conflicts
- Inter-linking of Rivers: Federalism, ecology and transboundary conflicts
- Water Law and its complexity, in theory and practice

ELIGIBILITY

This workshop is aimed at judges, practising lawyers, and everyone working in the water sector whose work includes engagement with legal issues related to water.
