### Subject: Constitution of the Centre for Post Graduate Legal Studies

The UGC's guidelines for establishment of the One year LL.M Programme mandates the establishment of a 'Centre for Post Graduate Legal Studies' (CPGLS). The UGC requires that the CPGLS should have full time qualified and experienced faculty members of not less than 10 members, consisting of a minimum of 4 Professors / Associate Professor in Law, who are involved in teaching the LL.M Course.
