

# National Conference on Corporate Laws

The logo of National Law University, Delhi is composed of 3 elements: n(N), L(L) and U(U) which are interlinked by the second element (L or Law). In its totality it represents the harmonious confluence of disparate elements (disciplines) and levels: a rule that law and its executive, the judicial system, also performs. Individually, the "N" and "U" are downward-and upward-facing respectively, symbolizing polar (and complementary) outlooks through which law threads its way. The extension of 'L' or Law to the last level (or layer) attempts to encapsulate the concerns of social justice. The emphasis is on the rule of Law (represented by the 't') in promoting social justice, particularly targeting those below baseline standards. Its columnar arrangement suggests an upholding of justice, equality, fraternity and human rights in all their facets in a secular democracy.
