As in previous years, the ICC International Court of Arbitration will be hosting social events throughout the 6<sup>th</sup> Indian Vis Pre-Moot. Should your team be selected to participate in the 6<sup>th</sup> Indian Vis Pre-Moot, please indicate the number of participants (and the capacity in which they represent the team) who are interested in attending the social events.

*Please note that National Law University, Delhi will provide accommodation for a limited number of teams on a first-cum-first-serve basis. There is a nominal registration fee of INR 2000 (USD 30 or EUR 28) for all teams opting for on-campus accommodation (i.e., even if one member per team opts for on-campus accommodation). However, the University's current infrastructure allows for on-campus accommodation for only up to a maximum of four participants per team.*

*For teams opting for off-campus accommodation, a nominal registration fee of INR 1000 (USD 15 or EUR 14) shall be charged.*

*The registration fee is payable separately for the teams participating in the Vienna and Hong Kong editions of the competition. For instance, if an institution registers both its Vienna and Hong Kong contingents for the pre-moot (including accommodation), then the total registration fee for the institution would be INR 2000 x 2 = INR 4000 (USD 60 or EUR 58)*
