The logo of National Law University Delhi is composed of 3 elements: n (N), L (L) and U (U) which are interlinked by the second element of L. In its totality, it represents the harmonious confluence of different elements of disciplines and level—a rule that Law and its executive, the judicial system also performs. Individually, the ‘N’ and ‘U’ are downward and upward facing, symbolising polar and complementary outlooks, through which Law threads its way. ABOUT THE UNIVERSITY

One of the youngest Law Schools in the list of premier Law Universities in India, National Law University Delhi was instituted by Act 1 of 2008 of the National Capital Territory, Delhi. The University has been recognised by the Bar Council of India under Section 7(1) (i) of the Advocates Act, 1961 and has been granted approval to conduct the five-year integrated B.A., LL.B. (Hons.) programme.

The University has been established with a mandate to create lawyers who are professionally capable, socially responsive and equipped to face the myriad challenges of an ever-evolving society. The vision of the University is to create a global legal institution which strives to be the best, both within as well as outside India, and to present individuals with a wide range of opportunities to contribute to the legal profession.

The curriculum and pedagogy at National Law University Delhi are designed to bridge the gap between theoretical concepts and their practical applications. The University aims to encourage novelty and scientific temper amongst its students,

enabling them to become pioneers of change for future generations. The commendable achievements of the students of National Law University Delhi within a short span of time stand testimony to the pool of skill and talent that this University has nurtured.

Dynamic in vision and robust in commitment, the University in merely a decade has proven promising results of becoming one of the best, recognised both Nationally and Internationally. More than an institution of teaching it has been a collaboration of teaching-learning-research, which brings together experienced and distinguished faculty from various strata of education and from some of the best Law schools in the world. This has created NLU into a space comprising a unique melange of eminent and senior members and young and talented members, all committed towards strengthening higher education in the Country.



University Infrastructure

The University flaunts its sprawling campus, situated at Dwarka, New Delhi, with a contemporary, trendsetting, and leading-edge infrastructure. Its facilities comprise of an Academic block (five floors), Halls of residence, Hostels separately for boys and girls (six floors), independent Administration block (five floors), a Library, and an Auditorium.

The campus is wi-fi (wireless friendly) enabled and the classrooms are well equipped with digital podiums, LCD projector with display screen, and 'E-Station Smart Multimedia Podium' used to facilitate teaching through audio-visual methods. The University has a fully air-conditioned auditorium with a seating capacity of over 650 people. It also houses four Conference/Seminar rooms, furnished with ultra-modern AV facilities, located at various floors of the Academic Block in the University.

The University provides access to state-of-the-art academic and research infrastructure; thereby enabling the students to pursue their interests. The Justice T.P.S. Chawla library has a rich collection of over 45,000 volumes of books, academic and reporting journals, committee reports, and other reference materials which include over 150 journal subscriptions and online journals. Further, the students are also provided on-campus as well as off-campus access to the best legal resources and digital databases including AIR Infotech, Manupatra, SCC Online, LexisNexis, Westlaw, HeinOnline, JSTOR, Hart eBooks, Kluwer Arbitration Online and eBooks of Taylor-Francis.

Y. K. Sabharwal Moot Court Hall and Moot Court Research Room:

The University has a pioneering E-Moot Court Hall equipped with the latest up-to-date high-tech AV equipment, with a seating capacity of over 170 people. Students studying here are habituated to real lifelike legal scenarios, by acquainting them with mootng through organising, attending, and participating in practice moots and competitions.

The Moot Court Research Room was inaugurated in August 2020. It has been constructed essentially for students to have a space to concentrate, study, and practice; and have resource material available to prepare for moot court competitions. Setup inside the library in its basement, it has a separate entrance for students. It houses previous moot memorials, compactors with a capacity of accommodating 2000 books, seating for more than 35 people, two staff members, four cassettes AC, and a projector to be placed soon.

In the first phase, as many as 1000 officials of different cyber labs will be trained at NLU Delhi campus.

Evaluation Criterion

At National Law University, Delhi, students are evaluated on a seven-point Cumulative Grade Point Average (CGPA). Evaluation is based on a series of periodic tests, semester examinations, research projects, dissertations and class presentations conducted throughout the semester.

Clinical Legal Education

Recognising that any legal education is incomplete without practical exposure, the curriculum at National Law University Delhi is the synergy of classroom teaching and clinical legal education, aimed at ensuring a stimulating and participative learning process that spans across disciplines. Our students are required to study four clinic courses which inculcate crucial skills such as drafting, conveyancing, pleading, trial advocacy, professional ethics and training in methods of alternate dispute resolution. The structure of the academic year at the University also permits students to undertake internships for the purpose of gaining professional experience.

Curriculum

NLU Delhi's curriculum is inspired by the 'UGC Curriculum Development Committee Report', to meet the challenging academic progressions posed by globalization; e-commerce; and transnational, legal, social, and political issues. The study curriculum addresses the myriad concerns of an Indian society intermingled with modern education involving legal literacy, poverty, human development, etc. The syllabi promote an inter-disciplinary approach, including aspects of clinical legal education as integral component of instruction and dissemination of knowledge.



RESEARCH AT NLU DELHI

The University has many illustrious Research Centres established to cater to diverse research and training needs of the society. The corpus of research funds of these centres run into Crores, and aids from Governmental agencies, higher judiciary, and International academia; partnering for various projects. The centres additionally offer significant opportunities to the students to indulge in research to build their competence. Currently there are 19 active Research Centres at NLUD.



Project 39A

Project 39A, previously known as the Centre on the Death Penalty, was established in 2014 to undertake new avenues of research on the criminal justice system, ensure competent legal representation for indigent prisoners sentenced to death, and open new fronts and methods of discussion on the death penalty, among various stakeholders and the public.



Centre for Innovation, Intellectual Property and Competition (CIIPC)

The Centre for Innovation, Intellectual Property and Competition was set up in 2015 with the aim of supporting academic and policy oriented dialogue in the individual and intersectional areas of innovation, intellectual property and competition.



Centre for Communication Governance (CCG)

The Centre for Communication Governance was established in 2013 to ensure that Indian legal education establishments engage more meaningfully with information law and policy, and contribute to improved governance and policy making.



Center for Law, Justice and Development (CLJD)

The Centre for Law, Justice and Development envisions revisiting, analysing and engaging with the development discourse and its interface with the legal discourse with the aim to participate in, contribute to and endeavour to mould the discourse as well as operationalisation of varied notions within the same in ways geared towards securing just domestic and international order.



Centre for Transparency and Accountability in Governance (CTAG)

Centre for Transparency and Accountability in Governance has been constituted to uphold the commitment of the rule of law and good governance. The Centre emphasizes on sensitizing people on transparency and accountability in governance; empowering people such as students, lawyers, and public officials to contribute effectively to ensure transparency and accountability in governance; and creating and promoting quality research in the area of transparency and accountability in governance.



Centre for Linguistic Justice and Endangered Languages (CLJEL)

Centre for Linguistic Justice and Endangered Languages (CLJEL) aims to facilitate an innovative approach towards the ongoing research and teaching thrust, and also to become a unique initiative in the country, a well as a role model for other legal education institutions for interdisciplinary work.



Centre for Tax Laws (CTL)

The Centre for Tax Laws was established in 2018 to work in the area of tax laws. A robust taxation framework helps in mobilizing revenue for governments' welfare commitments and serves as the backbone of a sound economy.



Centre on Criminology and Victimology (CCV)

The Centre on Criminology and Victimology promotes research and action in the areas of criminal justice and victimology and conducts training to wings of the criminal justice system, especially in the area of juvenile justice. Additionally, the Centre critically analyses and examines laws, policies and programmes from the perspective of the victim, with emphasis on protection, rehabilitation, participation and justice.



Centre for Transnational Commercial Law (CTCL)

The Centre for Transnational Commercial Law aims to be a national leader in private and governmental transnational commercial law research, teaching and discussion. It also engages in private and governmental transnational commercial law reform advice and policy evaluation, and provides consultative services to the government and other institutions dedicated to the development of transnational commercial law and practice.



Center for Human Rights and Subaltern Studies (CHRSS)

The focus of the Centre is researches on human rights related to the subaltern social groups, especially Dalits, women, indigenous communities and religious, ethnic and linguistic minorities.

Centre for Studies in Disability and Law (CSDL)

The Centre for studies in Disability and Law aspires to spearhead and contribute to the development of the interdisciplinary theoretical research, and advocacy frameworks necessary to remove the social, legal, physical, policy, and attitudinal barriers that exclude people with disabilities.

Centre for Banking and Financial Laws (CBFL)

The banking has been a foremost sector which has reformed the country's economy to a great extent. From its old paradigm of capital, labour and technology, the country's economic growth has shifted its gaze towards the mobilization of savings, their investments and returns.

Centre for Cyber Laws (CCL)

The Centre for Cyber Laws has been established to understand the socio-legal issues related to ever evolving cyberspace. Cyberspace is infinite and has potential to grow and evolve infinitely. The issues related to cyberspace are also evolving with the advancement of information technology.

Center for Comparative Studies in Personal Laws (CCSPL)

Research in the field of personal laws is required to be done in India due to its multicultural and religiously diverse society. As there is lack of uniformity in various matrimonial, succession and in other related issues under personal laws despite the directive enunciated under Article 44 of the Constitution of India regarding the endeavour of state to secure citizens, a uniform civil code, the need of such kind of in-depth research becomes a necessity, which is the one of the mandate of the centre.

Centre for Comparative Law (CCL)

The Center for Comparative Law was constituted with the aim to promote as well as to serve as a point of exchange of knowledge and expertise amongst the scholarly community involved in comparative legal studies, both within and outside the country.

Centre for Environmental Law, Policy and Research (CELPR)

The Centre was established in August, 2016. The fundamental objective of the Centre is to promote legal education and research in the field of environmental law.

Centre for Alternative Dispute Resolution (CADR)

The Centre for ADR has a vision to promote the use of ADR methods among the legal and non-legal professionals, students and general public at large. The Centre envisions a society which values harmony, peaceful co-existence and diversity.

Centre for Criminal Justice Administration and Human Rights (CCJAHR)

The Centre for Criminal Justice Administration and Human Rights aims to study and conduct research on the distribution and rationalisation of power among various functionaries with special emphasis on the investigation process, prosecution process and trial process including sentencing process.

Centre for Constitutional Law, Policy and Governance (Former)

The Centre for Constitutional Law, Policy and Governance focuses on foregrounding rights, rightlessness and other vulnerabilities in understanding, critiquing, and reforming laws, legal institutions and modes of governance, so that they reflect the constitutional ideals of justice.

Centre for Corporate Law and Governance (CCLG)

To bring academicians, professionals, legal experts, economists, regulators, judges, banking and financial law experts and students on panels for discussions as subject of Corporate Law is multidisciplinary in nature; to encourage debates amongst participants of the Center and produce academic research.

LIFE AT NLU DELHI

EVENTS ON CAMPUS

Oxford-Price Media Law Moot Court Competition

The 'Comparative Media Law and Policy' programme at Oxford University in collaboration with National Law University Delhi organises the South-Asia Rounds of the prestigious 'Price Media Law Moot Court Competition', annually at the NLUD campus. Started in 2010 as an India-qualifying round, the moot has grown tremendously to include participation from other South-Asian nations like Pakistan, Nepal, Bangladesh and Sri Lanka. It focuses on contemporary issues relating to media and information technology law and is well-known for its excellent judging standards.

NLU Delhi-Herbert Smith Freehills International Negotiation Competition

The University hosts the International Negotiation Competition in association with Herbert Smith Freehills LLP, London since 2014. Each year the participation and level of students' performance expertise progresses to further levels. In the recent past the competition has had 28 teams competing with each other, with 15 from across the globe; engaged in real-life simulations.

National Rounds, ICC Moot Court Competition

The University began hosting the national rounds of the ICC Moot Court Competition in 2016. The qualifying teams represent India at the international rounds of the competition held at The Hague, Netherlands.

Cultural Fest

Cultural fest is the annually held cultural festival of National Law University Delhi. The cultural festival is filled with a wide array of events, competitions and performances from students and artists participating from all across the country. Cultural fest is among one of the few cultural festivals organised by various law colleges in India.

Professor Ghanshyam Singh Memorial Parliamentary Debate

The Professor Ghanshyam Singh Memorial Parliamentary Debate is the flagship debating event of National Law University Delhi. The tournament is a traditional 3-on-3 style parliamentary debate. Started in the year 2011, the event has grown to become one of the biggest debating events in the country. The University has previously hosted 38 teams from various Universities, with combined prize money for this edition over 1.5 Lakhs INR for various categories.

Insolvency Moot Court Competition

The Insolvency Law Moot Court Competition, in association with the Insolvency and Bankruptcy Board of India is organised by the Centre for Transnational Commercial Law. The competition was the first of its kind, curated to simulate the proceedings under the Insolvency and Bankruptcy Code, 2016.

CCI Moot

National Law University Delhi, in collaboration with Competition Commission of India, organises National NLUD-CCI Moot, dedicated to the field of Competition Law. The first edition held in 2018, drew participation from various law colleges across India.

Bodh Raj Sawhny Memorial Oration

The Bodh Raj Sawhny Memorial Oration is being organised at National Law University Delhi for over five years. The lectures focus on contemporary politico-legal issues, delivered by renowned legal and non-legal luminaries, including Prof. Upendra Baxi, Shri Wajahat Habibullah, Prof. N. R. Madhava Menon, Dr. Shashi Tharoor and Ms. Santosh Yadav.



STUDENT COMMUNITIES

Increasing Diversity by Increasing Access (IDIA)

The University's student body actively participates in Mr. Shamnad Basheer's initiative to make learning of the law more accessible and inclusive to young children from various economic and social strata. Students are involved in training and mentoring aspiring law students as well as in sensitizing marginalized communities about legal education.

Cinema Club

The Cinema Club is a gateway to world cinema, exploring myriad themes to inculcate art appreciation and creative thinking. It provides a platform for discussions on many contemporary and relevant themes.

Enable

Enable is a student group dedicated towards providing support to disabled students by making everyday life more accessible. The group seeks to spread awareness and sensitize members of the University to the problems faced by the disabled community, and how the same can be addressed.

Gender Circle

The Gender Circle has played a prominent role in breaking gender stereotypes and creating gender sensitization on campus through various formal and informal interactive events, guest lectures and panel discussions.

Legal Aid

The University, through the Legal Services Committee, has been involved in fostering legal aid and awareness. The University has established a fully functional Legal Aid Clinic and the Clinic for Assistance in Labour Laws (CALL) -- an initiative to bridge the chasm between workers and the legal machinery, by providing access to quality legal aid. As a part of the HSF Community Engagement Awards, the initiative was selected as one of the five best legal aid initiatives in India. The University, through the Committee, has also constituted a pro-bono panel of practising lawyers who help the committee in its legal interventions.

Ambedkar Periyar Phule Study Circle

This is a student-led initiative extending support in academics to marginalized students in the University, especially those who are unable to utilize academic opportunities due to various social barriers and constraints. It also acts as a platform for discussion and debate on the issues of social justice, gender, caste, race and other contemporary issues in India through guest lectures, panel discussions and movie screenings.

Queer Collective

The Queer Collective is an independent student collective dealing with LGBTQIA+ politics and representation on campus. It has been involved in creating awareness on issues surrounding LGBTQIA+ rights through poster campaigns, movie screenings and discussion groups. It has invited speakers belonging to the LGBTQIA+ community to interact with students, and has participated in the Delhi Queer Pride Parade as well.

Engage

A student group geared towards encouraging a culture of thought and discourse on campus. This initiative will lay equal emphasis on University issues as it will on broader socio-political, economic, and cultural discussions through a variety of formats. While trying to resolve issues related to harassment and discrimination, attendance and academic performance, mental health, student governance, administrative transparency, etc. we intend to facilitate effective dialogue between various stakeholders, starting with the students, faculty, and the administration.
