OUR LOGO

The logo of NLU Delhi is composed of 3 elements: n (N), l (L) and u (U) which are interlinked by the second element L. In its totality, it represents the harmonious confluence of disparate elements (disciplines) and levels- a rule that Law and its executive, the judicial system also performs. Individually, the 'N' and 'U' are downward and upward facing respectively, symbolizing polar (and complementary) outlooks through which Law threads its way. The extension of L or Law beneath the level (layer) attempts to encapsulate the concerns of equality and social justice. The emphasis is on the 'Rule of Law' (represented by the L) in promoting social justice, particularly targeting the vulnerable population, which is lowest on the social ladder. Its columnar arrangements suggest an upholding of justice, equality, fraternity and human rights in all their facets to reach a secular democracy.

VISION

NLU Delhi follows a mandate to transform and redefine the process of legal education. The University aims to evolve and impart comprehensive and interdisciplinary legal education, which will promote legal and ethical values, while fostering the rule of Law. OUR EXCELLENCE - INSTITUTIONAL RANKINGS

National Institutional Ranking Framework (NIRF)

NLU Delhi has retained the second rank in the Law Category, in the latest National Institutional Ranking Framework (NIRF) Rankings released on Monday, 5 June 2023. This is the 6th time in a row that NLU Delhi has retained this rank.

The NIRF (National Institutional Ranking Framework) is a ranking system for higher education institutions in India which assesses HEIs on five parameters: Teaching, Learning and Resources (TLR), Research and Professional Practice (RP), Outreach and Inclusivity (OI), Graduation Outcomes (GO) and Perception (PR). It is released every year by the Ministry of Education (MoE), Government of India.

Honorable Vice Chancellor, NLU Delhi, Professor (Dr.) G.S. Bajpai said, *"I am extremely glad to see NLU Delhi as one of the top institutions in the country in the law category. Usually, achieving success is hard but maintaining it is harder. But the fact that NLU Delhi has maintained its rank for the 6th time in the row shows that NLU Delhi is truly deserving of the position and I am confident that with the collective talent and hard-work of my students, faculty & staff, we will soon reach rank No. 1 as well."*

I. NEW BEGINNINGS

1.a New Leadership



Professor (Dr.) G.S. Bajpai, Former VC, Rajiv Gandhi National University of Law (RGNUL), Punjab assumed the charge as Vice-Chancellor, NLU Delhi on Tuesday, 28 February, 2023. Professor Bajpai has become the third Vice Chancellor of NLU Delhi after founder Vice-Chancellor Professor (Dr.) Ranbir Singh was followed by Professor (Dr.) Srikrishna Deva Rao. Professor Bajpai has previously served as Registrar, NLU Delhi. He has also served as Professor of Criminology & Criminal Justice (Law); Chair Professor at K.L. Arora Chair in Criminal Law; as well as the Chairperson of the Centre for Criminology & Victimology at NLU Delhi. He has worked on several government projects and has served as member and convener on various central government and state government panels.

1.b. Appointment of Professor of Practice



Hon'ble Mr. Justice J.R. Midha, Former Judge, Delhi High Court joined NLU Delhi as Professor of Practice with effect from May 29 2023. The University will benefit immensely with his expertise and experience in building capacity in practical application of law.



II. NEW INITIATIVES

1. Appointment of Anti Discrimination Officer



In compliance with the UGC (Promotion of Equity in Higher Education Institutions) Regulations 2012, the University appointed Prof. Maheshwar Singh, Professor of Political Science, NLU Delhi as the Anti Discrimination Officer as per the provisions of the said regulations.

2. NLUD Abhyāsa Initiative

The NLUD Abhyāsa Initiative seeks to bring in experiences of practitioners and professionals in respective areas. The aim is to simulate the application of classroom learning in the real-world where the subtleties of practice inform how law is applied and justice is served. The objective of this policy perfectly aligns with the vision of offering ‘holistic’ education as per the National Education Policy 2020 in order to increase the “employability potential” of higher education programmes and the requirement to engage in ‘tutorials’ and ‘practical training’ as per the Bar Council of India - Rules of Legal Education – 2008.

3. Eklavya

Eklavya- the Research Affiliation Programme (RAP) is an effort by NLU Delhi to bridge the gap between legal academia and those who engage with the law in various forms outside the University. It is meant as an invitation to those who work with the law in myriad ways to engage with legal academia and in turn, it is also an opportunity for the University to benefit from perspectives that don’t usually find their way into academia. The tale of Eklavya, derived from the ancient Indian epic Mahabharata, embodies the remarkable capacity to seek knowledge and assimilate it through unconventional means. In today’s context, Eklavya symbolizes the expectation that educational institutions should embrace a more inclusive approach, allowing aspiring learners to freely pursue their quest for knowledge.

4. International Visitors Programme

NLU Delhi has instituted the International Visitors Programme, which is designed to facilitate interaction and collaboration with scholars from leading institutions across the world. The programme will enrich the academic and research ecosystem at NLU Delhi through interactions with outstanding international scholars.

5. National Scholars-in-Residence Programme

NLU Delhi has instituted the Scholars-In-Residence Programme, which is designed to facilitate interaction and collaboration with scholars from leading institutions and professionals / practitioners in India. It will offer opportunities to Indian scholars to develop their research and explore innovative ways of engaging with NLU Delhi faculty and students in a vibrant and learning environment including offering niche courses. It will also promote greater academic and research links with Indian institutions and individuals.

6. Inauguration of the India Chapter of the Daughters of Themis

Inaugural session of the India Chapter of the Daughters of Themis Network – helmed by Professor (Dr.) Harpreet Kaur, Professor of Law, was held on 20 May 2023. The India Chapter of the Daughters of Themis aims to provide a platform to women business scholars to connect and foster a community to facilitate sharing of research & knowledge and mutual support. It will provide mentorship and training opportunities for women in business and will advocate for policies to promote gender equality in professional domains.

7. Anubhūti- NLUJ Project Exemption Policy

The Anubhuti Policy applies to students of B.A.LL.B. (V Year Degree Programme) with regards to project exemptions. As per the policy, any student may avail a project exemption in any subject (except clinical courses and seminar courses) for the following:


- a. As allowed under the moot court policy under the direct supervision of the MCC faculty coordinator and duly approved by the Vice Chancellor.

1. Book Launch: Hate Crime in India: Understanding Nuanced Discrimination Against North-Eastern Population by Prof (Dr.) G.S. Bajpai



The Springer launched the much-awaited title - "Hate Crime in India: Understanding Nuanced Discrimination Against North-Eastern Population" authored by Prof. (Dr.) G.S. Bajpai, Dr. Garima Pal, Tusha Singh and Advait Tambe. The book adopts a victim-centric perspective, thoroughly examining the contextual elements and underlying factors that drive hate behaviour. It critically evaluates the existing constitutional and statutory provisions related to hate crime in India, thereby initiating a comprehensive discourse to formulate hate crime legislation.

5. 1st Annual Doctoral Law Colloquium on Law and Contemporary Issues in India (March 16-17, 2023)



NLU Delhi organized the 1st Annual Doctoral Law Colloquium 2023 on Law and Contemporary Issues in India on 16th and 17th March, 2023. The aim of the colloquium was to bring together doctoral candidates undertaking research within the broad theme of contemporary issues in law to provide a supportive and collaborative environment for exchange of ideas. The colloquium featured presentations by candidates nearing the completion of their dissertations and those at an earlier stage of their doctoral journey. The colloquium offered a panel discussion on research methodology to provide participants with a plurality of perspectives on current methodological debates.

The panelists were Prof. (Dr.) G.S. Bajpai, Vice Chancellor, NLU Delhi, Prof. (Dr.) V.G. Hegde, Professor, Jawaharlal Nehru University, Prof. (Dr.) Rukmini Sen, Professor, Dr B. R. Ambedkar University Delhi, and Prof. (Dr.)

Oishik Sircar, Professor, Jindal Global Law School. The panel was moderated by Mr. Aniruddha Jairam, Visiting Faculty, NLU Delhi. Subsequently, the final set of presentations was conducted and the colloquium ended with a valedictory session.

6.CCG organised a Summer School on Platform Governance (March 21, 2023)



The Centre for Communication Governance, NLU Delhi (CCG NLUD) hosted the seventh edition of the Summer School which was organized between the Hans-Bredow Institut, University of Hamburg, the Institute for Technology and Society of Rio De Janeiro (ITS Rio), and CCG NLUD. The goal of the week-long program was to bring together a diverse set of scholars, instructors, and students for an intensive week of lectures, discussions, and interactive classroom activities. While past editions of the Summer School have focussed on Data Governance, Freedom of Expression & Online Intermediaries, Privacy, Harmful Speech, Surveillance, and Data Protection, this year, the focus of the Summer School was on 'Platform Governance'.

For the summer school twenty students from Brazil and Germany were joined by eight students from the NLU Delhi. For the program, we welcomed seven instructors from the Hans-Bredow Institut and ITS Rio, who, alongside researchers from CCG NLUD and selected external instructors who conducted this year's lectures.

7. Fulbright- Nehru International Education Administrators Seminar (March 23, 2023)



NLU Delhi conducted the Fulbright Nehru International Education Administrators Seminar on 23 March 2023 organised by the Department of International Affairs, NLU Delhi. For the seminar, NLU Delhi hosted 14 educators from various top universities in the US to explore pathways to build ties and develop international and academic collaboration. On the occasion Professor (Dr.) G.S. Bajpai, Vice Chancellor, NLU Delhi, in his opening remarks said, *“As a research-intensive university, NLU Delhi has always given impetus to advance legal studies and develop new pedagogy, going forward, my interest is to explore our ties with United States – India Educational Foundation (USIEF), in order to develop mutually beneficial linkages and exchanges with the Universities in the US, for the benefit of our students and faculty.”*

“The idea is to forge fresh ways of partnership and take solid and substantive steps to advance legal education. We have already set up a Department of International Relations at NLU Delhi, and soon we will start an independent International Visitors’ Programme under which scholars and researchers can come to NLU Delhi to teach and carry out research. We are also looking to introduce a joint degree programme in which we will encourage a multidisciplinary approach to explore the interface between social sciences and law,” added Professor Bajpai.

8. Another Victory for Project 39A, SC Frees a Death Row Convict (March 28, 2023)

A proud victory for Project 39A at NLU Delhi, as the Supreme Court of India set free a death row convict, who was only 12 at the time of the offence, while acknowledging that he could have been imprisoned only for a maximum of 3 years but has now served 28 years (25 of those years on death row). Project 39A, National Law University, Delhi briefed Justice Basant to argue this matter in the Supreme Court. Judgment was authored by Justice Aniruddha Bose for a bench that also comprised Justices KM Joseph and Hrishikesh Roy.

9. Inauguration of Institutional Repository, NLUD (April 6, 2023)

Prof. G S Bajpai, Vice Chancellor and Prof. Harpreet Kaur, Registrar National Law University Delhi inaugurated the Institutional Repository of National Law University Delhi VIDYA GYAN SANGRAH @NLUD and Library Publication: Library Manual and Index to Indian and Foreign Legal Articles. Vol.4 (2016-2022)

VIDYA GYAN SANGRAH @ NLUD is a platform for showcasing and visualizing scholarly and intellectual assets produced by University's faculty, researchers and students. The repository provides access to Archival library Classic law books, Archival Library law reports, NLUD press publication, LL.M Dissertations, PH.D. Thesis, Lectures and Videos, Question Bank, Newspaper Clippings, NLUD Research Centre Publications, University Publications and many more.

10. Presentation by Prof. (Dr.) G.S. Bajpai before the Parliamentary Standing Committee (April 17, 2023)

Prof. (Dr.) G.S. Bajpai, Vice Chancellor, NLU Delhi was invited by Parliamentary Standing Committee to make a presentation on the subject "Strengthening Legal Education in view of Emerging Challenges before Legal Profession" on 17 April 2023 at the Rajya Sabha Secretariat. The meeting was Chaired by Sh. Sushil Kumar Modi, Hon'ble member, Rajya Sabha. The Vice-Chancellor, NLU Delhi in his presentation covered various aspects of legal education and legal reforms, globalization of education, revising the legal curriculum and suggested ways and means to further strengthen the relationship between Statutory Bodies, Universities and State Government.

11. Law Commission of India Invites Prof. (Dr.) G.S. Bajpai to Provide Consultancy In Area of Criminal Law & Reforms (April 25, 2023)

The Law Commission of India invited Prof. (Dr.) G.S. Bajpai to provide consulting inputs to the ongoing studies in the realm of Criminal Law & Reforms on 25 April 2023. The Commission sought inputs on its various reports on the subject viz. Age Determination of Juvenile, Sedition Law, Amendments in Prevention of Corruption Act and Laws relating to Bail. The Commission further requested NLU Delhi to provide research assistance in some of the above mentioned projects by way of deploying a team of researchers. The Commission appreciated the University's contribution in various research reports and a particular mention was made about genesis of report no. 277 on 'Wrongful Prosecution'

Prof. Bajpai has agreed to provide regular support to the Law Commission of India on its various ongoing projects besides supporting the Commission in various upcoming projects.

12. Delhi High Court Cites CCG's Working Paper in its Judgment (May 1, 2023)

We are proud to share that Delhi High Court, in its recent judgment, has cited and relied on the conceptual frameworks developed by CCG, in its Working Paper on 'Tackling the Dissemination and Redistribution of Non-Consensual Intimate Images (NCII)'. The Paper has been cited twice with its extracts being reproduced in paragraphs 29 and 56 within the text of the judgment. The judgment was delivered by Hon'ble Mr. Justice Subramonium Prasad of the Delhi High Court.


This development is a testament to CCG's excellent work in this field and demonstrates the impact of its research.

14.CCG Research Report: "Mapping the Blockchain Ecosystem in India and Australia" (June 14, 2023)



CCG launched a new research report titled "Mapping the Blockchain Ecosystem in India and Australia." This report is the outcome of the 1st phase of a research project that studies the blockchain ecosystem in India & Australia, consistent with a shared vision of both countries for an open, free, rules-based Indo-Pacific, funded by the Australia-India Cyber and Critical Technology Partnership grant.

The report focuses on stakeholder awareness, attitudes towards technical standards and significant blockchain use cases that will be studied more closely in future project reports.

1.Internationalization

i.NLUD signs MOU with University of Waikato, NZ



NLU Delhi signed a Memorandum of Understanding with The University of Waikato, New Zealand in the pursuit of conducting collaborative research, exploring cross-border student and faculty mobility programs & developing joint academic activities including seminars, workshops and conferences. The MoU was signed by Professor (Dr.) G.S. Bajpai, Vice Chancellor, NLU Delhi and Professor Neil Quigley, Vice Chancellor, University of Waikato. NLU Delhi and Waikato share a common interest in furthering international academic scholarship and research through collaborative arrangements. The MoU sets out the both parties' wishes to develop a relationship based on the principles of mutual respect and international connectedness. The MoU will be valid initially for a period of five years

ii.NLUD signs MOU with University of Melbourne

NLU Delhi signed a Memorandum of Understanding with The University of Melbourne represented by Melbourne Law School. Through the partnership, the two institutions intend to support their mutual interests in research collaboration and/or joint research projects; Promotion and support of joint PhD opportunities; Exchange of academic staff; Organisation and hosting of joint conferences; Organisation of lectures and/or symposia; and/or Exchange of academic information or material.

2.Promoting Research in Niche Areas

i.NLUD signs MOU with IIPPI

With an objective to promote high-quality research in the field of insolvency and bankruptcy, the Indian Institute of Insolvency Professionals of ICAI has signed a Memorandum of Understanding (MoU) with the NLU Delhi to award a fellowship to one student to pursue Ph.D. in the domain of the insolvency and bankruptcy laws and regulations. This fellowship shall be available for admission from next academic year (2024). It shall be disbursed in installments over three years of the Ph.D. programme.

ii.NLUD signs MOU with International Financial Services Centres Authority (IFSCA)



NLU Delhi entered a Memorandum of Understanding with International Financial Services Centres Authority to foster cooperation in areas of financial institutions and regulations. Under the MoU, IFSCA has instituted a PhD Fellowship in IFSCA Regulations to incentivise research in the area of financial regulations at the University. The fellowship shall provide a scholarship amount of Rs 16 lakh per scholar and will be supervised by the Centre for Regulatory Studies (CRS) at NLU Delhi under the capable guidance of Professor M. S. Sahoo, Distinguished Professor, NLUD & Chairperson, CRS & Dr. Risham Garg, Associate NLUD & Director, CRS.

3.Rebuilding Ties

i.NLUD renews MOU with MNLU

NLU Delhi renewed a Memorandum of Understanding with Maharashtra National Law University, Nagpur. Through this partnership, the Universities will collaborate on mutually agreeable academic events, teaching, training, and research. The MoU will help foster academic collaboration between the two institutions, including joint research, publications, and faculty & student exchange. Additionally, the two Universities will pursue and develop joint training programmes over the course of the next five years.

I.EVENTS

Professor Srikrishna Deva Rao, the then-VC, in his Welcome Address said, *"Despite our early success as a leading legal educational institution of India, our future is contingent upon our ability to respond to changes in the legal education ecosystem of the country. We seek to expand our horizon as a multidisciplinary education institution and focus on internationalization. i. Recruitment Coordination Committee Outreach Lecture Series (March 16, 2023)

The Recruitment & Coordination Committee at National Law University, Delhi organized the first lecture of its Outreach Lecture Series. The lecture was delivered by Ms. Rupinder Malik (Partner at JSA) on Anti-Corruption and White Collar Crimes, in which she highlighted the contours of laws pertaining to white-collar crime and underscored the work that has been done in white-collar crime litigation practice. Ms. Malik has had over 25 years of experience representing a wide variety of business, industries and sectors which includes 9 years of experience at Baker McKenzie. She is also a chapter leader of the Indian Chapter of the Women's White Collar Defence Association.

The Outreach Lecture Series aims to provide students with practical insights into legal practice by holding interactive sessions with distinguished lawyers of the Indian legal industry.

ii. Talk on 'Regulatory Response to Menace of Fake Reviews' (March 16, 2023)

The Chair on Consumer Law, NLU Delhi organised a talk on 'Regulatory Response to Menace of Fake Reviews' on 16 March, 2023, in the light of World Consumer Rights Day. The talk was delivered by Ms. Nidhi Khare, Additional Secretary (Consumer Affairs) & Chief Commissioner of Central Consumer Protection Authority. During the talk, Ms. Khare discussed the various initiatives taken by the Department of Consumer Affairs, especially the launch of a framework for safeguarding and protecting consumer interest from fake and deceptive reviews in e-commerce.

iii. Outreach Lecture Series (April 5, 2023)

The Recruitment & Coordination Committee at NLU Delhi organized the second lecture of its Outreach Lecture Series on 5 April 2023. The lecture was conducted by Mr. Gautam Saha (Partner at TT&A) on Mergers and Acquisitions. The session covered the basics of M&A and Private Equity Transactions. - Journal of Victimology and Victim Justice published by NLU Delhi in collaboration with SAGE Publications is a University Grants Commission – Consortium for Academic Research Ethics (UGC-CARE) listed journal, that was started in the year 2018 under the Editorship of Prof. (Dr.) G.S. Justice T.P.S. Chawla Library



NLU Delhi's library has been named after the Hon'ble Justice Tejinder Pal Singh Chawla former Chief Justice of Delhi High Court (20 August 1986-16 August 1987). The TPS Chawla Library is stocked with major legal scholarship and research works, works of legal theories, legal manuals, state/ central government reports, NGO's reports and archival manuscripts/documents. Currently, the library has a collection of over 45,000 print documents, more than 15,000 eBooks, 9,800 e-Journals and 23 comprehensive electronic databases covering law and social development resources.

Recently, Justice T.P.S Chawla Library added to its repository access to digital newspapers by subscribing to the leading daily The Hindu and the

financial newspaper The Hindu BusinessLine. Both ePapers can be accessed by the faculty and the student- body alike. The Library also has subscriptions to prominent digital portals such as LiveLaw and Bar&Bench, which pertain to legal news, information, debates and discussions. Justice T.P.S. Chawla Library aims to support teaching, research and scholarship by serving as a rich source of valuable knowledge. It strives to provide information not only through traditional means but also through latest technological mediums.

Internet/Computer Centre

The campus is wi-fi (wireless friendly) enabled. The internet centre is located in the Library and has 50 high end desktops with Microsoft operating system and well equipped with optical drives. Besides this a separate bay is also provided for laptop users. The internet centre is supported with three servers and with a high speed bandwidth, centrally document & print facility is also available.

Digital Classroom

Our classrooms are well equipped with digital podiums, LCD projector & display screen and internet (wi-fi) access. The students are required to purchase laptops for making best use of internet connectivity for research purposes. All the classrooms have e-Station Smart Multimedia Podium for teaching. The e-Station is equipped with the facilities of touch screen, writing, sound system, visualizer, CD player and recording etc.

Auditorium

The University has a fully air-conditioned auditorium with a sitting capacity of over 650 people. The auditorium is equipped with the latest state-of-the-art audio and visual facilities. The auditorium is used for organizing University functions including seminars, conferences and cultural programs.

Seminar Rooms

NLU Delhi has four Conference/Seminar rooms furnished with ultra-modern AV facilities, located at various floors of the Academic Block in the University. These are available for booking after due notice for various events intended towards students, faculty and administration, along with external events.

Y.K. Sabharwal Moot Court Hall

The University has a pioneering e-Moot Court Hall equipped with the latest up-to-date hi-tech audio visual equipment having a seating capacity of 170 people. Students studying here are habituated to real life like legal scenarios, for acquainting them with mooting through organizing, attending and participating in practice moot court and competition

X. INFRASTRUCTURAL AMENITIES

The University has a sprawling campus at Dwarka with state of art infrastructure facilities consisting of an Academic Block (five floors), separate Halls of Residence for boys and girls (six floors), an independent administration block (five floors), a fully air-conditioned Auditorium for holding conferences and seminars. The University is fully residential and maintains separate residences for boys and girls. The Halls of Residence are provided with a common room with facilities of indoor games, like T.T & Pool, a common television and a state-of-art Gymnasium. Management and maintenance of discipline in the halls of residence is the responsibility of the residents, Chief-Warden and Wardens. The residents have to mandatorily conform to the rules and regulations of the University.

Sports/Games



The University has a basketball court, volleyball court and a badminton court. Separate gymnasiums for boys and girls are available in their respective Halls of Residence, equipped with the latest equipment. More facilities for sports are planned in the additional land which will be available to the University for the purpose, shortly.

Transport Facilities

The University also has two Innova Cars and a bus which is used for the student's activities such as court visits, Legal Aid Programmes and Clinics. The University is very well connected through Metro Rail and DTC bus services

Medical Centre & Ambulance

The university has a 24-hours medical room with a nurse. A doctor visits the campus from 4-6 p.m. every day. An ambulance is available round the clock for the residents of the University to deal with any emergency situation.

Banks

NLU Delhi has banking extension facilities through UCO Bank and HDFC Bank. Students may avail banking services on demand by contacting banking authorities. The University also has an HDFC ATM machine installed in the Cafeteria.

Community Spaces

NLU Delhi has a spacious cafeteria, also known as a dining hall or food court in the university campus, where students, faculty, and staff can purchase meals and beverages. The cafeteria serves a variety of food options and is open for breakfast, lunch, and dinner. The cafeteria serves as a central gathering place for students to socialize and network with their peers. The University also has an Amul Kiosk which serves beverages, food and snacks for students and faculty.

XI. WELL-BEING SUPPORT

Counseling Department

The Counseling Department works for the holistic well-being and mental health needs of the NLU Delhi community. It's the department's vision to provide and co-construct a framework that facilitates the well-being of the students and the employees by creating awareness about various psychological concepts, providing psychological services and sharing empirical and research-based techniques for working with everyday issues and personal growth. It's the department's endeavor to review, restructure and add to the initiatives as per the social and environmental demands as seen in the case of the pandemic. This overarching vision is implemented and achieved through Individual Counseling sessions, wherein the students can directly contact the counselors for an in-person or online

session. Group and individual orientation sessions for the first years. Workshop and discussion session where various psychological themes and management techniques are discussed. Drafting Mental Health booklets. Facilitating peer interaction through various activities and initiatives. The department runs under the guidance of NLU Delhi faculty-Ms. Deep Jajmaan & Ms. Priyam Bhattacharya.

YourDOST Counseling Services

NLU Delhi entered into a partnership with YourDOST-a counseling and emotional support, technology platform, designed to foster mental health. It anonymously connects individuals with the right experts, consisting of psychologists, psychotherapists, counselors, life coaches, career counselors who understand and can guide individuals through completely confidential one on one sessions. It is capable of providing counseling through web and mobile platforms.

NLU Delhi helps manage the well-being of its campus community through this platform. It is accessible to NLU Delhi students, faculty members and staff that come from a diverse range of countries, regions, cultures, socioeconomic backgrounds, age groups, religions, interests, etc.

XII.STUDENT COMMUNITIES

Gender Circle

The Gender Circle has played a prominent role in breaking gender stereotypes and creating gender sensitization on campus through various formal and informal interactive events, guest lectures and panel discussions

Cinema Club

The Cinema Club is a gateway to world cinema, exploring myriad themes to inculcate art appreciation and creative thinking. It provides a platform for discussions on many contemporary and relevant themes. The Cinema Club organises a movie screening every Monday at 9 PM. The movies include a wide variety including documentaries, world cinema, critically acclaimed movies etc.

Enable

Enable is a student group dedicated towards providing support to the students with disabilities by making everyday life more accessible. The group seeks to spread awareness and sensitize members of the University to the problems faced by the students with disabilities and how the same can be addressed.

Legal Aid

The University, through the Legal Services Committee, has been involved in fostering legal aid and awareness. The University has established a fully functional Legal Aid Clinic and the Clinic for Assistance in Labour Laws (CALL) - an initiative to bridge the chasm between workers and the legal machinery, by providing access to quality legal aid. As a part of the HSF Community Engagement Awards, the initiative was selected as one of the five best legal aid initiatives in India. The University, through the Committee, has also constituted a pro-bono panel of practicing lawyers who help the committee in its legal interventions.

Ambedkar Periyar Phule Study Circle

This is a student-led initiative extending support in academics to marginalized students in the University, especially those who are unable to utilize academic opportunities due to various social barriers and constraints. It also acts as a platform for discussion and debate on the issues of social justice, gender, caste, race and other contemporary issues in India through guest lectures, panel discussions and movie screenings.

Engage

A student group geared towards encouraging a culture of thought and discourse on campus. This initiative lays equal emphasis on University issues and the broader socio-political, economic, and cultural issues. The topics for discussion are usually related to harassment and discrimination, attendance and academic performance, mental

health, student governance, administrative transparency, etc. Engage intends to facilitate effective dialogue between various stakeholders starting with the students, faculty and the administration.

Queer Collective

The Queer Collective is an independent student collective campus. It has been involved in creating awareness on issues surrounding LGBTQIA+ rights through poster campaigns, movie screenings and discussion groups. It has invited speakers belonging to the LGBTQIA+ community to interact with students, and has participated in the Delhi Queer Pride Parade as well.

Philosophy Club

Under the supervision of Professor Maheshwar Singh, the Batch of 2025 has created the Philosophy Club to spread an appreciation for philosophy within the University and law schools in general. The club conducts various discussions on a host of fundamental philosophical texts and ideas, hosted lecture series by leading academics, disseminated easily accessible learning resources and notes, and much more. STUDY AT NLU DELHI

I. DEGREES OFFERED THROUGH AILET

1. Undergraduate Programme [B.A.LL.B. (Hons.)]

The five-year integrated B.A.LL.B. (Hons.) Degree Programme is the flagship course of NLU Delhi. This is a comprehensive interdisciplinary law degree that is aimed at building a strong foundation of law along with an all-round socio-political and economic understanding. Admission to the course is on the basis of merit as assessed through the All India Law Entrance Test (AILET), conducted annually. In order to be eligible for the course, the students must have completed senior secondary (Class 12th) education in any stream. After the completion of the course, students are equipped for professional or academic pursuits.

2. Post-graduate Programme [LL.M. Programme]

The LL.M. Degree programme is aimed at developing a deeper and focussed understanding in the area of specialization. To be eligible for admission to the LL.M. programme, a candidate should have passed the LL.B. or an equivalent degree from a recognised university, with not less than 55% marks on aggregate (50% for reserved category). Admission is on the basis of merit as assessed through the AILET. The programme is designed to inculcate research skills and analytical abilities. At the end of the final semester, students have to compulsorily submit a dissertation on the topic of their choice. This degree equips the students to pursue a career in academic, research, legal practice, and administrative & judicial services.

3. Doctoral Programme [Ph.D.]

NLU Delhi's doctoral programme is a research-intensive programme designed for post-graduate students and equips them for careers in scholarship and teaching. As a University policy, NLU Delhi, encourages multidisciplinary research, thus, students can research in law or related subjects through the disciplinary perspectives of social sciences or humanities. The aim of the programme is to produce a substantial body of work that adds value to the academic field while enabling the students to become independent researchers and scholars in their respective fields.

II. SPECIALIZED ACADEMIC PROGRAMMES

Diploma, Executive Diploma & Certificate Courses and Fellowships

1. LL.M. Professional

The LL.M (Professional) programme is a specialized educational offering designed to enhance the skills, knowledge, and leadership capabilities of senior-level professionals and executives in various fields. It is designed to cater to individuals who are already established in their careers and seek to stay ahead in a rapidly evolving economic and social landscape. LL.M (Professional) programme is designed to provide an immersive learning experience, combining theoretical concepts with real-world case studies and practical insights. Participants engage in interactive discussions, collaborate with peers from diverse backgrounds, and benefit from the expertise of experienced faculty members. The curriculum of an executive program is tailored to address the specific challenges faced by executives, covering topics such as strategic thinking, decision-making, innovation and effective communication. By participating in this programme, professionals can acquire new perspectives, deepen their knowledge base, broaden their networks, and gain the skills necessary to drive organizational growth and success in today's dynamic economic and social environment.

2. Bridge Course

NLU Delhi is one out of four prominent institutions nominated by the Bar Council of India (BCI) to offer bridge courses in the country. This course is taken by an applicant who seeks equivalence of his/her LL.B. degree obtained from abroad with an Indian LL.B. degree. The course is mandated by BCI for candidates holding foreign LL.B. degrees and seeking admissions in Indian Universities. It can be undertaken either in one year or two years as per the choice of the candidate.

3. L2Pro Master Classes

The Centre for Innovation, Intellectual Property and Competition (CIIPC) in collaboration with the IPR Chair at NLU Delhi and Cell for IPR Promotion and Management (CIPAM), Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry started a series of Master Classes on Introduction to L2Pro E-Learning Platform for IPR Training and Awareness. The online Master Classes are aimed at raising awareness regarding intellectual property rights amongst students and preparing them to navigate the L2Pro platform, its content and assessments. The course is being offered to all Indian university students across disciplines.

4. Forensic Mental Health and Criminal Justice

Project 39A in collaboration with Eleos Justice at Monash University has developed a course on forensic mental health and criminal justice. This four-week course explores the legal and forensic mental health aspects in three broad areas - fitness to stand trial, the defense of insanity, and the role of mental health in capital punishment cases. The course also has a comparative law element with experts from the UK and Australia. For an interactive and engaging experience, it has been designed to include discussions, polls, case studies and quizzes in addition to the lectures by the experts. The course has been curated on the basis of the extensive research and criminal defense work conducted by Project 39A in the area of mental health and criminal justice.

5. Decoding Forensics for Legal Professionals

Project 39A in collaboration with Eleos Justice at Monash University has created an interdisciplinary course on forensic science and law. This six-week course explores the scientific concepts underlying forensic pathology, medical examination in cases of sexual offenses, bite mark evidence and forensic DNA profiling. The course also discusses the legal standards for the examination of expert evidence. The course brings together forensic and legal experts from India and Australia to create this interactive learning experience with short video lessons, articles, mock case scenarios and quizzes. The course has been inspired by the extensive research and criminal defense work conducted by Project 39A in the area of forensics.

6. Climate Justice and Climate Law: South-North Perspectives

NLU Delhi and the Law Environment and Development Centre (LEDC), SOAS University of London, offered a two-week online certificate course on climate justice titled 'Climate Justice and Climate Law: South-North Perspectives' from 27 June- 8 July 2023.

The course was focused on the intersection between climate justice and climate change law and policy, framed around understanding justice linked to equity within and among countries. The central axis for understanding climate justice at the international level is differentiation, or the idea that equity requires the global North to do more than the global South in addressing climate change. At the national level, inequality calls for ensuring that the most marginalized and poorest citizens are not made to bear the brunt of policies addressing climate change. This course framed these issues by emphasizing the global South-global North dimensions of the international climate change regime and focusing on India as one significant example for understanding climate justice at the national level. The course brought together experts from the global South and global North. It employs a unique pedagogical approach of combining lectures, class exercises, self-study and course work. Roundtable discussions and interactive talks with experts also form an integral part of the programme.

7. Technology Law and Policy Certificate Course

The Centre for Communication Governance (CCG) has launched the first edition of Technology Law and Policy Certificate Course. The Course is designed to ensure the nuanced engagement of the students with the legal, public policy and socio-political contours of technology and cyberspace, their implications for our society and its

regulation. The course engage with key themes in technology law and policy including data protection and privacy, platform governance, cybersecurity and information security, regulation of emerging technology, intellectual property, and competition law. Students are exposed to current and proposed legislation on cyber laws in India and globally, global policy developments, comparative jurisprudence tracking the evolution of rights and emerging challenges and risks. This course equip students with the necessary understanding and knowledge required to effectively navigate the rapidly evolving space of technology law and policy, and assess the contemporary developments.

8. Diploma Course in Insolvency and Bankruptcy: Law, Practice, Regulations

The Centre for Transnational Commercial Law (CTCL) launched its flagship Diploma in Insolvency and Bankruptcy: Law, Practice, Regulations (DIB). This course aims to provide an exposure and in-depth understanding of law, practice and regulations of the Insolvency and Bankruptcy Code, 2016, to government officials, policy makers, working professionals, practitioners in legal, secretarial, accountancy, academics and researchers. The course focuses on juxtaposition of the practical aspects, legal principles and propositions within the realm of business and entrepreneurship with development of cumulative and comprehensive understanding of insolvency laws. The course also aims to acquaint and equip the participants with the practical skills relevant to insolvency laws in the courts and tribunals in India along with the requisite negotiation and problem-solving skills.

9. Post Graduate Diploma in Urban Environmental Management and Law

NLU Delhi and WWF India together offer a Post Graduate Diploma in Urban Environmental Management and Law (PGDUEML) which is a specialized course that focuses on strengthening the delivery capacity of urban administrators and environment professionals. PGDUEML is designed to provide in-depth knowledge and understanding of existing urban laws, by-laws and policies. The course seeks to equip its participants to tackle the loopholes in the present institutional mechanisms and to propose innovative changes. The course is intended towards the training and capacity building of all those persons concerned with and involved in improving living conditions and quality of life for urban citizens in various capacities by providing them with policy prescriptions, innovations for better urban governance, information and training inputs. It aims to strengthen the human resource pool by creating efficient urban managers.

10. Post Graduate Diploma in Environmental Law and Policy

With an aim to provide a better understanding of green law issues poignant worldwide, particularly in the Indian context, NLU Delhi and WWF India jointly offer a one-year Post Graduate Diploma in Environmental Law and Policy. The exclusive tailor-made programme provides opportunities for law graduates and other professionals working in the field of environment to enrich their understanding of the issues, institutions and initiatives in the field of environmental law and policy. It will provide comprehensive knowledge to participants in Environmental Law and Policy and also increase their understanding on key issues related to national as well as international environmental law & policies and help develop practical skills to facilitate effective engagement with Environmental Laws.

11. Post Graduate Diploma in Tourism and Environmental Law

WWF India along with the NLU Delhi offer a Post Graduate Diploma in Tourism and Environmental Law (PGDTEL). The programme is suited to benefit all tourism providers and prospective tourism service providers. It aims to assist professionals and fresh graduates to develop a better understanding of the tourism industry, especially in relation to those working in areas of ecotourism. The programme includes perspectives on all the new developments and new insights into the relationship between tourism and the environment dealt with at both the global and the regional level. This exciting course will be unique as it covers the scope and nature of ecotourism in today's market and looks at the sources and types of opportunities available within this fast growing industry.

12. Criminal Justice Student Fellowship

NLU Delhi's Project 39A offers a twelve-month fellowship to law students to work and contribute to Project 39A's research and pro bono legal representation endeavors. Fellows assist with archival, doctrinal, comparative, and field research across the areas of Project 39A's work, i.e. accountability for torture, death penalty, forensics, mental health and criminal justice, sentencing and the Fair Trial Programme. They also assist in writing research reports and journal articles dealing with contemporary issues in the field of constitutional and criminal law in India. The

fellowship is offered to a total of 3 candidates for 12 months each. On the successful completion of the fellowship (12 months), a sum of INR 35,000 is offered to the fellows.

13.Fair Trial Fellowship

NLU Delhi's Project39A's Fair Trial Fellowship programme is supported by a grant from the Azim Premji Philanthropic Initiatives. Under the fellowship, the Legal Fellow is assigned to work on cases of undertrial prisoners being represented by Delhi State Legal Services Authority (DLSA) panel lawyers and is in charge of providing assistance in court hearings, legal research, drafting and prison visits (for client interviews) to the legal aid lawyer leading the case. The Fellowship will train and mentor a group of young professionals to work in collaboration with the State Legal Services Authority towards ensuring fair trial for undertrial prisoners at both pre-trial and trial stages. The Fellowship is being currently rolled out for work in Nagpur and Pune Central prisons. The maximum period of engagement under the fellowship is three years and the contract will be renewed on an annual basis.

IV.ALL INDIA LAW ENTRANCE TEST

All India Law Entrance Test (AILET) is conducted annually in the month of December by NLU Delhi for admission into the B.A.LL.B.(Hons.), LL.M. and Ph.D. Programmes. The exam is conducted in the offline mode in the pen-paper format. The duration of the test is 120 minutes.

V.RESERVATION POLICY

1.Scheduled Castes (15%) and Scheduled Tribes (7.5%) Categories

In order to claim reservation under these categories, the candidate must have a valid certificate issued by the competent authorities. Any unfilled seat(s) reserved for Scheduled Castes (SC) will be converted to Scheduled Tribes (ST) and vice-versa and will not be offered to any other reserved category. In case sufficient number of eligible candidates of Scheduled Castes and Scheduled Tribes are not available in the respective category, the seats thus remaining vacant will be treated as General and will be offered to the General Category candidates in

order of merit. A list of approved Competent Authorities for the issuance of Scheduled Castes and Scheduled Tribes certificates is as follows: -

2.Other Backward Classes (OBCs)-Non-Creamy Layer (22%)

22% seats are reserved for OBCs (Non-Creamy Layer) Category. The candidate possessing a valid OBC (Non-Creamy Layer) certificate issued by the competent authority under the Central List of OBCs or under the Delhi State List of OBCs (Notified by the Government of NCT of Delhi) will be eligible to apply under this category.

The non-creamy layer certificate should be issued on or after 1st April 2022.

3.Economically Weaker Section-EWS (10%)

A total of 10% seats are reserved for the Economically Weaker Section (EWS). The benefit of reservation under EWS can be availed upon production of a valid Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authority, shall only be accepted as proof of candidate's claim as belonging to EWS:

4.Persons with Disabilities (PWD) 5% horizontal reservation

Horizontal reservation of 5% has been provided to the candidates belonging to Persons with Disabilities (PwD) category in accordance with the provisions of "The Rights of Persons with Disabilities Act 2016". The candidates possessing a valid PwD certificate issued by the competent authority as per the provisions of "The Rights of Persons with Disabilities Act 2016 will be eligible to apply under this category.

5.Kashmiri Migrants (KM)-One Supernumerary Seat

One supernumerary seat is earmarked for Kashmiri Migrants. Kashmiri Migrants include Kashmiri Pandits/Kashmiri Hindu Families (Non-Migrants) who are living in the Kashmir Valley. A valid certificate issued by the competent authority for availing benefit under this category is to be produced by the candidate at the time of provisional admission. Since the seat of Kashmiri Migrant quota is supernumerary, it will not be converted at all in any other category in case it remains unfilled.

6.Residents of Jammu and Kashmir- Two Supernumerary Seats

Two supernumerary seats are earmarked for Residents of Jammu & Kashmir. A valid certificate issued by the competent authority for availing benefit of this category will have to be produced by the candidate at the time of provisional admission. Since the seats of Residents of Jammu & Kashmir category quota are supernumerary, they will not be converted at all in any other category in case they remain unfilled

7.PwD Category

5% Horizontal Reservation across the categories has been provided to the PwD Category candidate.

The committee scrutinizes applications of students and also their performances in previous exams. The interest amount of endowment donated by Dr. Santosh Chawla w/o late Justice T.P.S. Chawla, Former Chief Justice, Delhi High Court, is used towards this financial assistance.
- **Fee Waiver** to deserving and needy students granted by the Vice Chancellor, NLU Delhi. The fee waiver is allowed to the student in need of financial assistance, on the recommendation of the committee constituted by the Vice Chancellor.


