The National Law University, Delhi has appointed Prof. (Dr.) Anupama Goel, Professor of Law, as the new Registrar of the University

"In exercise of powers under statute 6(3) of the National Law University Delhi, I am pleased to entrust the duties of the Registrar with Prof. Anupama Goel, Professor of Law, in addition to her present duties with effect from 11 January 2021 till further orders. During the period of holding the charge of the post of Registrar, the administrative, financial and statutory powers delegated to the Registrar, shall be exercised by her," stated an order issued by the VC.

Dr. Anupama Goel joined NLU Delhi in August 2012 as Associate Professor (Law), and has taught Constitutional Law and International Law to undergraduate students and Comparative Public Law to postgraduate students.

She has been a member of Academic Council and Executive Council at the National Law University for the year 2013-2014. She is currently a member of the Postgraduate Council.

Dr. Anupama Goel started teaching at Department of Laws, Punjab University, Chandigarh in 1994. She was conferred her Doctorate of Philosophy by the Punjab University, Chandigarh in 2003, for her thesis titled "Social Justice and its Implementation with Special Reference to the State of Punjab". She has taught diverse subjects to LL.B, LL.M. as well as Ph.D. students, including Constitutional Law, International Law, Interpretation of Statutes, Environmental Law, Human Rights and Law of Torts. She has also published various papers on different areas of law in prestigious journals, including the Journal of the Indian Law Institute (JILI). While at Punjab University, was a founding member of Placement cum Counselling Cell of Department of Laws, Punjab University, Chandigarh. She also remained a member of the Board of Control on various occasions.

She joined NLU Delhi in August 2012 as Associate Professor (Law), and has taught Constitutional Law and International Law to undergraduate students and Comparative Public Law to postgraduate students. She has been a member of Academic Council and Executive Council at the National Law University for the year 2013-2014. She is currently a member of the Postgraduate Council, Life member of Indian Law Institute and also a member of Indian Society of International Law, New Delhi.

4TH INTERNATIONAL INSOLVENCY AND BANKRUPTCY MOOT COMPETITION 8-10 JANUARY 2021 (VIRTUAL)

The National Law University Delhi, in collaboration with INSOL India and Society of Insolvency Practitioners of India (SIPI), supported by the Insolvency and Bankruptcy Board of India (IBBI) and the UNCITRAL Regional Centre for Asia and the Pacific, had initiated a Moot Competition on Insolvency and Bankruptcy in 2017. The Centre for Transnational Commercial Law at National Law University Delhi ("CTCL") is the Organising Body for this Moot.

Insolvency Law is a sophisticated and complex economic law. It is one of the most critical components of the financial architecture of any country involving a wide range of stakeholders. It is critical that the students of law,

commerce, and management understand the nuances of this specialised subject, by both education and training in this field.

This Moot is the first of its kind in India, and it was conceived as a platform to enable students of the Law Universities and Schools of Management and Economics to engage with various stages of the insolvency process; wherein the simulations are as close as possible to the actual proceedings before the NCLT. The 4th edition of IBMC was virtually conducted on 8th-10th January 2021. More than 50 teams representing institutions from around the world registered and participated in the competition.

After a Memorandum Qualification round, 16 teams from the following institutions were shortlisted and made it into the Oral Rounds:

National Law University Odisha; Government Law College, Mumbai; National University of Singapore; Chanakya National Law University, Patna; Symbiosis Law School, Pune; ILS Law College; Symbiosis Law School, Noida; Auro University; Maharashtra National Law University, Nagpur; Institute of Law, Nirma University (ILNU); SVKM's Pravin Gandhi College of Law, Mumbai; School of Law, Christ University; The National University of Advanced Legal Studies (NUALS); National Law University, Jodhpur; Dr. Ram Manohar Lohiya National Law University; and MNLU, Mumbai.



After the Preliminary Oral Rounds which were judged by professionals proficient in the law, 4 teams qualified into the Semi Final Round: Dr. Ram Manohar Lohiya National Law University; National University of Singapore; School of Law, Christ University; and National Law University Odisha.

Dr. Ram Manohar Lohiya National Law University and School of Law, Christ University made it into the Final Round of the competition, which was judged by Dr. M. S. Sahoo, Chairperson, Insolvency and Bankruptcy Board of India, Ms. Pooja Mahajan, Managing Partner, Chandhiok & Mahajan, Advocates and Solicitors, Mr. Dhananjay Kumar, Partner, Cyril Amarchand Mangaldas & Fellow INSOL International. Their presence was morale boosting for the finalists and after an interesting and gruelling round, School of Law, Christ University was unanimously declared winners of the moot! The Valedictory Ceremony of the competition was graced by legal luminaries and esteemed dignitaries. Dr. Risham Garg, Associate Professor of Law & Director, Centre for Transnational Commercial Law (CTCL), National Law University Delhi, spoke about the

moot. Prof. Dr. Srikrishna Deva Rao, Vice Chancellor, National Law University Delhi, delivered the Welcome Address. Shri. Amarjit Singh Chandhiok, President, INSOL India, gave the Special Address.

JOINT FACULTY WORKSHOP-NLUD AND IIT DELHI (MAY 25, 2021)

The Indian Institute of Technology, Delhi (IIT Delhi) and the National Law University, Delhi (NLU Delhi) held a virtual Joint Faculty Workshop on 25th May 2021 to explore research and academic partnerships in the field of technology and law. The workshop was designed as a platform for a meaningful exchange of ideas between faculties from both institutions. The purpose was also to discuss and work towards specific academic and research projects between IIT Delhi and NLU Delhi.



The session began with an introduction to the workshop by Prof. Bolia, Department of Mechanical Engineering, IIT Delhi. Prof. Ramgopal Rao, Director, IIT Delhi, and Prof. Srikrishna Deva Rao, Vice Chancellor, NLU Delhi then addressed the faculty, highlighting the need for higher education to be more

interdisciplinary, inter-professional and international. This is in keeping with the National Education Policy 2020 that encourages interdisciplinary learning and partnership.

Further, joint supervision of Ph.D. projects, auditing of courses at both institutions by students, joint certificate programs, and training courses for industry professionals or government bodies, were emphasized.

Faculty members from both institutions then presented research work undertaken, and the scope for future collaborations within a range of subject areas such as intellectual property rights, science diplomacy, criminal law, artificial intelligence, forensic science, and statistics. Faculty from NLU Delhi began presentations with Prof. Harpreet Kaur and Dr Arul George Scaria who spoke on the idea of a 'Joint Startup Incubation Centre'. Dr. Anup Surendranath and Shreya Rastogi from Project 39A spoke on 'Digital Forensics' in the criminal justice system. Dr. Daniel Mathew from the Centre of Communication Governance spoke on the Interface of Law, Policy and Technology. This was followed by presentations from faculty at IIT Delhi. Prof. Archana Chugh, Kusuma School of Biosciences spoke on assessing the role of intellectual property rights in Science Diplomacy. Prof. Ankush Aggarwal, Department of Humanities and Social Sciences presented on India's official statistics and the underlying legal framework. Prof. Nomesh Bolia, Department of Mechanical Engineering and Coordinator, DAKSH Centre of Excellence for Law & Technology, spoke on case management and data in the judiciary.

Professor Daniel Martin Katz, Chicago Kent School of Law delivered the Keynote Speech on the need for technology to define and solve systemic failures in the legal system. The session ended with a Vote of Thanks by Dr. Scaria, who

encouraged further conversations between faculty at IIT Delhi and NLU Delhi, and emphasized the need to enrich this partnership between experts in technology and law. Both institutions are in the process of signing a Memorandum of Understanding that will encompass interdisciplinary and collaborative teaching and research.

NLU DELHI TEAM WINS 'OXFORD INTERNATIONAL IP LAW MOOT 2021'




Anupriya has worked on action-oriented policy projects concerning rights of survivors of sexual violence, women


