#### Terms and conditions:

- 1. The hotel is required to provide hygienic and neat & clean space.
- 2. All cooking items to be used in the preparation of food should be fresh and of good quality. While preparation of the food, all material to be used have ISI, AGMARK certification and of reputed brand.
- 3. Any loss due to theft, breakage in crockery, furniture etc. or any other items will be borne by Hotel/Restaurant.
- 4. The Hotel/restaurant shall provide all good quality items and maintain high standard and the serving staff should be properly dressed in clean uniform.
- 5. The maximum distance of Hotel/Restaurant shall be within 6.5 kilometers of the NLU premises.
- 6. The Hotel/Restaurant should have sufficient indoor dining space to accommodate approximate 200 persons.
- 7. The rates are exclusive of GST, Income tax (TDS) etc. If any with to be deducted from the payments at source by NLU Delhi in terms of provision of income tax act, 1961 for which necessary certificate tax deduction shall be furnished by NLU Delhi to Hotel/Restaurant.
- 8. Hotel/Restaurant will be required to serve drinking water as per menu/program.
- 9. The agency is required to submit its quotation on their letter head.
- 10. Cutting and overwriting in the quotation are not allowed. If, there is cutting and overwriting such quotation will not be entertained.
- 11. The quotation received after last date and time of submission will not be entertained.
