Chair and the Centre for Innovation, Intellectual Property and Competition (CIIPC) at NLU Delhi in association with the Cell for IPR Promotion and Management (CIPAM) celebrated the Azaadi ka Amrit Mahotsav from 25th November 2021 to 15th August 2022. In furtherance of the vision statement of the Honourable Minister of Commerce and Industry, Shri. Piyush Goyal, the aim of this campaign was to reach as many university/college students, particularly from technical universities/colleges/institutes, and equip them with a basic grounding in Intellectual Property. As part of the same, a series of Master Classes on Introduction to L2Pro India E-Learning Platform for IPR Training and Awareness was organized to promote IPR learning. Developed through a joint collaboration between Qualcomm Inc., CIIPC at NLU Delhi and CIPAM- DPIIT, the L2Pro India E-Learning Platform is a valuable means to impart IPR training & awareness across different proficiency levels viz., Basic, Intermediate and Advanced Levels. 5. Covid-19 and its impact on Commercial Contracts Research Working Paper 30-Dec-2021 by CTCL-NLUD This research primarily aimed to analyse the impact of the COVID-19 on commercial contracts and suggested solutions to navigate through the pandemic induced contractual roadblocks. The paper included four sections. The first section attempted to evaluate the knock- on effects of the pandemic on international trade and contracts. It mainly focused on the effect of COVID-19 on the performance of various industries, contractual obligations, business cycles and insolvencies. Additionally, it evaluated how the pandemic has contributed to the interpretation of pre-pandemic negotiated contracts. The second section dealt with relevant doctrines and principles, including force majeure clauses, the doctrine of frustration, the doctrine of supervening illegality, etc. These are frequently invoked when the performance of a contract becomes impossible. It not only dealt with the basic content of these doctrines and principles but also relates them significantly to an event such as the pandemic. The third section analysed whether an event resembling COVID-19 has been accommodated by international conventions i.e. UPICC, CISG, and PECL. A detailed study of the provisions under the international conventions has been carried out in this section. The fourth section endeavoured to provide comprehensive solutions to the readers on how to escape the legal implications of COVID-19 in terms of mitigating risks. It dealt with addressing the possibility of losses before signing the contract, finding alternatives and suggesting ways to

execute them. Overall, the research served as a comprehensive guide for the readers on the impact of COVID-19 on businesses and commercial contracts and also serve as a point of reference for future course of action. http://nludelhi.ac.in/news2.aspx?id=40203

Clinic III ('Legal Aid'), requires students to conduct empirical research that aids marginalized communities. Clinic IV ('Trial and Appellate Advocacy'), highlights the significance of advocacy skills and professional ethics and their inculcation in students. Students are also exposed to mooting, alternative dispute resolution, and client counselling exercises.

Currently, University provides the law subjects like jurisprudence, History of Legal & Constitutional Development in India (HLCD) integrating the Indian knowledge system in legal education. The University is developing a course on Ancient Legal System.

A number of new outcome-based diplomas, certificates, LLM (Pro) and other vocational programs are floated regularly for keeping pace with the dynamic business environment. NLUD also offers multiple seminar courses to students in their penultimate and final years that allows them to better understand the practical application of law while approaching different legal issues with a more advanced and nuanced approach.

22.Distance education/online education:

The University runs several programs which are delivered to learners in ODL/ Blended and on-campus modular mode. The NLUD library is supported by diverse online databases which provide ready and quick information to the students. It provides remote access that allows its students and faculty to make use of legal databases and use the library for research purposes from anywhere in the world by simply logging in. The University' Massive Open Online Courses (MOOCs), Econtent on e-PG-Pathshala, SWAYAM can be easily accessed by anyone, anywhere, and at any time free of cost. It also offers online diplomas namely, (i) Diploma in Law and Practice of Arbitration (ii) Diploma course in Insolvency and Bankruptcy: Law and Practice. The university offered three month certificate course online course on Business and Commercial laws.

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which is reflected in Programme outcomes (POs), Programme Specific Outcomes(PSOs) and Course Outcomes(COs) of the Programmes offered by the University			

The University's primary objective is to impart a comprehensive interdisciplinary legal education which will empower students to address the various contemporary challenges of public concern. To meet this objective the University's curricula at all levels (UG, PG and Ph.D.) is designed to promote legal and ethical values, foster the rule of law and develop the skills to critically examine, analyse and apply the law. The course on Constitutional Law ensures that students have a strong grounding of the Constitutional Framework and promotes constitutional values in students. Subjects like International Law and Political Science that familiarises students with the fundamental concepts of international law and provides students with insights into the international legal system, world affairs and international relations. The Clinical Courses ensure that students are exposed to the practical workings of the Courts, develop their advocacy skills, inculcate professional ethics and reach out to society via the organisation of legal aid. Additionally, seminar courses offered to the Students of the IVth and Vth year provide students with an understanding of niche areas of law. . Besides, the university invites both national and international external experts for providing special courses as well as special lectures. The University's various initiatives to facilitate participation in international exchange programmes, and summer schools facilitate in meeting the objective of introducing students to multicultural environments.

1.3 - Curriculum Enrichment

1.3.1 - Institution integrates cross-cutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability, and Human Values into the curriculum

The University envisages that the legal education being imparted should be abreast with societal needs and concerns. To this end the curriculum has integrated issues which are of relevance to Professional Ethics, Gender, Constitutional and Human Values, Environment and Sustainability, etc. Human and Constitutional values are promoted through courses on Constitutional Law and Political Science which introduce students to Fundamental Rights and Duties. The course on Human Rights, International Humanitarian & Refugee Law furthers the discourse on human rights which include issues on gender. The courses on Jurisprudence, Sociology and Family Law also introduce students to nuances of gender, duties and social structure of the society. The area of environment and sustainability is introduced to students through subjects like Environmental Law which provide students with an understanding and appreciation of the critical issues of global concern like climate change and biodiversity loss. In the area of Business Law as well subjects like Company Law offers insights into Environmental Social Governance and gender dynamics. Professional Ethics is also taught to students in the Clinic Courses.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problemsolving methodologies are used for enhancing learning experiences

The University utilizes a variety of student-centric methods as a part of the teaching-learning process through lectures, seminars and

tutorials. For instance, in order to facilitate peer learning and feedback, projects are presented by the students to the whole class. Assignments and examinations are application-based, and involve problem-solving based on hypothetical situations requiring application of the law. The four compulsory clinical courses, namely Clinic - I (Alternative Dispute Resolution), Clinic - II (Legal Drafting), Clinic - III (Legal Awareness), and Clinic - IV (Trial Advocacy) have a greater weightage in terms of credits than regular courses in order to promote experiential learning. The University offers seminar courses (two in the fourth year, and four in the fifth year of the B.A.LL.B. course) touching upon a wide range of subjects such as climate change, disability law, criminology, etc., and are taught by experts from India and abroad. The University has also created the Buddy over Batches Project, wherein each new student is assigned senior students from each of the four batches above, to facilitate advice and issue resolution during the initial stage. The University's Student Welfare Committee prepares the list of the students assigned in such a manner and shares it with the incoming batch.

The University clears applications for promotion of the faculty members under the Career Advancement Scheme (CAS) without any delay. The University supports the participation of faculty members in conferences/seminars; twice a year in case of domestic conferences/seminars, and once in two years with respect to international conferences/seminars. A maximum leave of one week may be availed in this regard per semester, although this requirement is not applicable for the vacation period. In order to incentivize research publications, the University's Executive Council, vide item No. 3.6 dated 25.09.2021 (https://nludelhi.ac.in/download/ssr/21.pdf), has approved a policy providing a financial incentive of Rs. 20,000 for each article published in journals that form part of the SCOPUS, Web of Science, or UGC Care list, as well as an additional list of Indian and foreign leading and reputed legal and sociolegal journals. The faculty members will be provided with such journals. The University also provides Rs.10,000/- annually to each faculty member for purchase of books. The University has approved establishment of various research centres. The University fully reimburses indoor medical expenses of the faculty and their dependent family members, whilst paying a fixed monthly medical allowance for outdoor medical expenses.

As part of IT integration in the examination procedures and processes, and in order to facilitate fair and transparent examination management, the examination system of the University has been integrated by the examination department of the University with Turnitin, which is a software that detects plagiarism. On or before prescribed deadlines, students are able to upload any end-term examinations that may be based on open-book exams and upload the same on their respective Tunitin classes. Subsequently, the examination department sends the file to respective faculty members for evaluation after downloading and decoding the same, except in the case of internal assessment. The files are handed over the faculty members through a Google Drive. Thereafter, an excel sheet containing the marks is sent across by the faculty. After vetting and moderation in accordance with university policy, the marks are uploaded on TCS-ion, where they may be accessed individually by the students. From february 2022 all examinations are start conducted offline mode.

ARPD was set up to consolidate, strategies and execute the University's vision as an institution of higher education and research. It is chaired by the Vice Chancellor, and its members include the Registrar and three faculty members. For instance, under the aegis of the ARPD, in a unique partnership, National Law University Delhi signed a Memorandum of Understanding with IIT Delhi for initiating wide-ranging research and academic collaborations in various interdisciplinary areas at the intersection of law, social sciences and technology, including artificial intelligence, forensic science, cyber laws and cybercrimes. A consistent effort is made by the university for promoting research by faculty members and students. The latest databases and books are purchased by the university for ensuring resources for research. The internationalisation policy of the university also includes research collaborations. The research incentive scheme of the university has been implemented to motivate teachers for writing. The Academic Fellowship is a flagship programme created by the University to nurture early career academics in teaching and research. The fellow began full-time work in November 2021. The university has attempted to bring about interdisciplinary learning through research centres and faculty initiatives.

NLUD therefore engages in various activities that will provide students with opportunities to engage with the community and develop an empathy for those who are affected by societal concerns. A Pro-Bono Club was constituted at National Law University Delhi in collaboration with the department of Justice in March 2022. The club which has a membership of both faculty and students is dedicated towards promoting equal access to justice. The primary objective of the Pro-Bono Club is to inculcate in students a sense of social responsibility through various activities which include litigation assistance and community care legal assistance. Such activities have provided avenues to students to offer legal assistance and promote legal awareness. Clinic III provides opportunity to students to engage directly with society through different specilaised clinics on consumer protection, mohalla clinics, family clinic, insolvency clinic etc. The university also has a legal aid clinic. Besides, Satya Pro- bono collaborative initiative of the university, Chairs on Consumer Law and Access to Justice provide such opportunities to students.

National Law University Delhi has an integrated residential campus in Dwarka that has state- of- the- art infrastructure and facilities including an Academic Block with air-conditioned classrooms, wi-fi access, a whiteboard, e-Podium, and an installed overhead projector.

The University's meeting rooms and e-Moot Court Hall are equipped with the latest electronic equipment. The University has four highend seminar/conference rooms with state-of-the art facilities including high-quality audio-visual equipment, and recording facilities. Wi-Fi facility is available throughout for video conferencing.

National Law University Delhi, Justice TPS Chawla Library: The library is well equipped with a collection of books, ebooks, journals, e-journals, magazines, newspapers etc. It has a Reading Hall, Researchers Rooms, Moot Court Room, automated ILMS, and has digitization facility. LSmart solutions based on RFID and EM technologies are available for library automation and security. Moreover, RemoteX Technology for accessing electronic databases through cloud computing technology, and 'Digital Access Portal'(DAP), to access digital resources from anywhere in the world through 'Remote Login' are also available. The Internet Centre is supported by three servers and with high-speed bandwidth. It provides Reprographic Services. The library has JAWS screen-reader software for the aid of visually impaired members of the University. It has membership of the British Council and the American Centre for access to additional learning resources.

The University has an Auditorium with a sitting capacity of 550 persons and state-of-the-art Audio/Video equipment for the presentation and recording of various programs.

Sports Facilities: The University has an on-campus Badminton Court, a Basketball Court, a Tennis Court and a Volleyball court. Students are often found playing in these courts, which is good for their fitness, health, and entertainment. There is a children's playground for small kids of the faculties and threewell-equipped Gymnasiums.

The University has separate Halls of Residence for both Boys and Girls. The rooms are fully furnished with special care for the differently-abled. Both premises are fully air-conditioned and have a power backup facility through high-powered generators. Every floor and block has water purifier systems attached with a water cooler and solar energy fuelled geysers. Both premises have 24-hour Wi-fi connections and a Common Room with Television, Indoor Games facilities, and Lounge seating arrangements. They also have a spacious Dining Hall and well-equipped Gymnasiums. As per Covid Protocol, they have Sanitizer Dispensing Machines at the entrance. Both premises are maintained by the Housekeeping Staff coordinated by a Supervisor and guarded by Security Guards.

Various Faculty-Student committees, notably the Monitoring Committee, were formed during the Covid pandemic lockdown to ensure seamless operation of online classes and timely settlement of any complaints or grievances that arose in that regard. These committees acted as a conduit for crucial information to move between the administration, faculty, and students. Inauguration of the Enabling Unit - the Enabling Unit's mission is to make life at the university more accessible for students with disabilities by removing impediments to their growth and development. Its functions include: (a) assisting the entrance of persons with disabilities; (b) offering guidance to persons with disabilities; and (c) raising awareness about the needs of disabled people, and disability-related issues. All the committees in the university are created to assist in decision making and are the examples of participating management.

6.3 - Faculty Empowerment Strategies

6.3.1 - The institution has a performance appraisal system, promotional avenues and effective welfare measures for teaching and non-teaching staff

NLUD has adopted a performance appraisal system and promotional avenues as per UGC Regulations for the promotion of faculty members under CAS. UGC Regulations require a self-appraisal report by the faculty members. APAR is written for non-teaching employees every year. Promotions to the non-teaching staff are allowed on the recommendations of the Departmental Promotion Committee subject to the availability of vacant posts. Further, the University has adopted the Modified Assured Career Progression (MACP) Scheme of the Government.

Medical Reimbursement: The teaching and non-teaching staff members are covered under the Medical Regulations under which full reimbursement of the medical expenses for treatment of the employee and their dependent family members is provided by the University. In addition to it, the University is also paying the Medical Allowance of Rs.2000/- per month along with a salary for outdoor treatment.

Leave Travel Concession, Earned Leave/Medical Leave, Maternity Leave, Child Care Leave, EPF are availed as per rules/regulations of the University/Government of India.

Bonus: Non-productivity linked bonus paid to employees as per the policy of the Government of NCT of Delhi.

EPF: University has adopted EPF Scheme for its employees. Children Education Allowances as per rules/regulations of the University/Government of India can also be availed. Academic leave for conferences and seminar given to faculty. The University has Crèche facility for teaching and non-teaching members. Gymnasium and counselling facility is also available in the campus.

The NLUD Act defines the functions of the Finance Committee and the Executive Council. Annual Budget proposals are made by the Finance committee and Executive Council to the Governing Council. The Governing Council considers these financial statements/budget estimates and gives its approval. The expenditure is incurred according to the approved budget. The University has always tried to mobilize the financial resources mainly from the following:

University has established the five chairs and generated an endowment of more than 3.50 Crores. The funds kept in the FDR's and interest generated thereon were utilized for the purpose of fulfilment of the objective of establishment of the chair. Research Centres, Training Programmes, and Student fees are various ways to generate funds. The University has obtained a registration certificate from the Ministry of Corporate Affairs for availing funds under Corporate Social Responsibility from companies.

6.5 - Internal Quality Assurance System

The IQAC initiated various quality assurance measures for improving various aspects of University functioning. In the IQAC meeting held on 12 June 2021 and 25th April 2022, recommended the following for adopting best practices in academic and research for enhancing standards of the University and initiated some plan of action.

1. Improvement in Curriculum, Teaching Learning and Feedback system:

The CDC received suggestions from various students' committee and conducted open house discussions to review the course structure, value addition through interdisciplinary courses, seminar courses. The Under Graduate curriculum course restructuring has been done by CDC through various sub-committees including UG examination reform. The IQAC has conducted online training sessions for faculty members to enhance teaching and learning experiences.

2. Research Facilitation and Institutional Repository: IQAC has adopted various policies for supporting faculty participation in research and their retention. The faculty members contributed written works in UGC care list journals, Scopus and Web of Science. The University research centres have made significant contribution through research report and international projects. To support quality measures, the IQAC also proposed appointment of Dean in various sections Academic affair, Student affair, Alumni Relations, Research, Planning and Strategic Development, and International Affairs. University also initiated Institutional Repository Committee to keep records of the faculty achievement and publications.

Through their involvement in research and affirmative action initiatives, students become aware of social, legal, and national issues, motivating them to actively reduce barriers to justice and work towards an equitable society. These initiatives have garnered national and international recognition for National Law University, Delhi, as research-driven institution with conducive learning environment for legal education.
