The inaugural edition of the competition was held during 28-29<sup>th</sup> October 2017 at the National Law University, Delhi, India.

The theme of the 2022-23 edition is ‘Corporate Insolvency including Cross- Border Insolvency’. Teams will be shortlisted based on the quality of submissions. In the oral rounds, teams will make the arguments on merits to industry experts acting as judges.
