Call for Applications for Consultants (Designer & Illustrator; Graphic Designer)

The National Law University, Delhi ('University') is seeking to engage **two** consultant 1-designer & illustrator and 1-graphic designer to work on the calendar design for the year 2020 for Project 39 A. The contract will be for a period of 2 months.

About the Organisation:

Project 39A draws inspiration from Article 39-A in the Indian Constitution on equal justice and opportunity in the legal system. We work on issues specific to the criminal justice system, and undertake litigation, research and outreach relating to forensics, torture, legal aid, forensic psychiatry and death penalty (for more information on Project 39A, visit www.project39a.com).

Responsibilities:

- A. Creative input relating to developing a suitable design for the calendar for the year 2020.
- B. Working on illustrations for the calendar based on the design and theme.
- C. Creating and communicating design options and illustrations suitable for the calendar.
- D. Finalizing the design and illustrations for the calendar, based on feedback and in coordination with the staff.

Qualifications for designer and illustrator:

- A. Graduate in Fine Arts or Graphic Design or both.
- B. Relevant experience of working as an illustrator.
- C. Relevant experience of working with a reputed graphic design firm.
- D. Availability to complete the assignment by November 2019.

Qualifications for graphic designer:

- A. Graduate in Graphic Design.
- B. Relevant experience of working with a reputed graphic design firm.
- C. Availability to complete the assignment by November 2019.

Compensation: Remuneration will be commensurate with qualifications and experience and will be approximately in the range of Rs. 40,000-45,000 per month for the designer and illustrator and Rs. 30,000-Rs.35,000 per month for the graphic designer.

Duration of the Contract: The contract will be for a period of 2 months, subject to completion of design for the calendar.

Application Process: Interested persons may send their resume and portfolio of their work. Please send your resume and portfolio of work to the p39a@nludelhi.ac.in . The subject of the e-mail should be “**Project 39A- Application for Consultant (Designer & Illustrator) for Calendar**”. The cover letter must state (Attn: Executive Director, Project 39 A).

The University reserves the right to conduct interviews and also to not fill these positions. The University will be unable to cover the costs for attending the interview but the possibility of a telephonic/video interview can be explored.

Deadline: Applications must reach us by midnight of September 22, 2019. Applications received after this date will not be considered.
