The National Law University, Delhi ('University') is seeking to engage a consultant (Designer) to work with and further the aims of the Centre on the Death Penalty. The contract will be for a period of six (6) months.

**About Project 39A:** Project 39A draws inspiration from Article 39-A in the Indian Constitution on equal justice and signals the broadening of our engagement with the criminal justice system in India. The Project undertakes litigation, research and outreach relating to forensics, torture, legal aid, forensic psychiatry and death penalty (for more information on Project 39A, visit [www.project39a.com](http://www.project39a.com)). Project 39A is headed by the Executive Director, Dr. Anup Surendranath (Assistant Professor of Law, National Law University Delhi) and has 12 full-time associates involved in litigation, mitigation, research and public outreach.

**Responsibilities:**

- A. Designing of the material for the upcoming events (invitations, banners and posters)
- B. Design the centre's research publications - Annual Statistics 2019 report and Designing of Sentencing Project Report, Mental Health Research Project Report.
- C. Creative input and designing relating to the Centre's communication material
- D. Any other work that may be necessary to fulfill the Centre's objectives.
