The National Law University, Delhi ('University') is seeking to engage **one** consultant (designer & illustrator) to work on the calendar design *for the year 2019* for Project 39 A. The contract will be for a period of 2 months.

#### **About the Organisation:**

Project 39A draws inspiration from Article 39-A in the Indian Constitution on equal justice and opportunity in the legal system. #### **Responsibilities:**

- A. Creative input relating to developing a suitable design for the calendar for the year 2019.
- B. Working on illustrations for the calendar based on the design and theme.
- C. Creating and communicating design options and illustrations suitable for the calendar.
- D. Finalizing the design and illustrations for the calendar, based on feedback and in coordination with the staff.

#### **Qualifications:**

- A. Graduate in Fine Arts or Graphic Design or both.
- B. Relevant experience of working as an illustrator
- C. Relevant experience of working with a reputed graphic design firm.
- D. Availability to complete the assignment by November 2018.

**Compensation:** Remuneration will be commensurate with qualifications and experience and will be approximately in the range of Rs. 35,000-40,000 per month.

**Duration of the Contract:** The contract will be for a period of 2 months, subject to completion of design for the calendar.
