### **1. Prof. (Dr.) A. Jayagovind**

Prof. A. Jayagovind obtained his Ph.D. in International Monetary Law from Jawaharlal Nehru University, New Delhi. He has specialized in International Trade Law both in its public and private aspects and has published extensively in these areas. He was one of the founding faculty members of National Law School of India University (NLSIU), Bangalore and served the Institution till 2011. He was the Chair Professor of WTO Studies and subsequently as the Vice-Chancellor of NLSIU. Thereafter, he joined NLUD as a Visiting Professor. His teaching interests include the World Trade Organization, International Commercial Transactions and Private International Law.

### **2. Prof. (Dr.) Philippe Cullet**

Prof. Philippe Cullet, LL.M, MA (Lon), JSM, JSD (Stanford) is Professor of International and Environmental Law and the Director of the Law, Environment and Development Centre (LEDC) at SOAS University of London. He is also the Convenor of the International Environmental Law Research Centre and a Visiting Professor at the National Law University, Delhi. Prof. Cullet's main areas of interest include environmental law, natural resources, human rights and the socio-economic aspects of intellectual property. He works on these at the international level and in India. His current research includes work on water law and governance with a particular focus on groundwater, drinking water, sanitation and institutional reforms in India; equity in environmental law; biodiversity, including benefit sharing and biosafety; and justice, with a particular focus on environmental and water rights.

### **3. Prof. (Dr.) Anupam Jha**

Prof. Anupam Jha obtained his Ph.D. in International Criminal Law from the Faculty of Law, University of Delhi. He is presently a professor of law at the Department of Law, University of Delhi. In 2014, he was awarded the Raman Research Fellowship for Energy, Environment, and Natural Resources Law from the University of Kansas. He is a life-member of Indian Law Institute and Association of British Scholars. His areas of interest include international criminal law, law on human trafficking, international terrorism and law, and law on renewable and nuclear energy.

### **4. Prof. (Dr.) Umakanth Varottil**

Prof. Varottil is currently a professor of law at the National University of Singapore. He specializes in corporate law and governance, mergers and acquisitions and corporate finance. While his work is generally comparative in nature, his specific focus is on India and Singapore. He has co-authored or co-edited five books, published articles in international journals and founded the IndiaCorpLaw Blog. He has also taught on a visiting basis at law schools in Australia, India, Italy, New Zealand and the United States. He is currently an editor of the Oxford Business Law Blog, Indian Law Review, Asian Journal of Comparative Law and Singapore Journal of Legal Studies and is also a Research Member of the European Corporate Governance Institute.

#### **5. Prof. (Dr.) Dipa Dube**

Prof. Dube is the Dean Rajiv Gandhi School of Intellectual Property Law, IIT Kharagpur. She obtained her Ph.D. from the University of Calcutta. She has taught courses on criminal laws, criminology, penology, evidence, etc. in reputed institutes of India such as NUJS, Kolkata and NLU Jodhpur. She has many books and articles to her credit, and has attended several national and international conferences and delivered lectures on invitation at various national institutions. Her areas of research interest include gender violence, crimes against women, police and prison system, and victims of crimes.
