The first meeting of all the members of Internal Quality Assurance Cell (IQAC) was convened by the Director & Coordinator, IQAC on June 19, 2015 at 12:30 p.m. in the Meeting Room, Academic Block, NLU Delhi. The Agenda of the meeting was as follows:

- 1. To take stock of existing subjects in the curriculum of B.A. LL.B (Hons.) Programme
- To discuss the scheme of papers and their respective position in various semesters of B.A. LL.B. (Hons.) Programme.
- 3. To discuss about Seminar Courses and Elective Courses
- 4. Suggestions for inclusion of additional items to be discussed in next meeting of IQAC
- 5. Any other item with the permission of the Chair

The Director& Coordinator, IQAC welcomed all the member in the meeting and intimated that NLU Delhi has recently filed for accreditation with National Assessment and Accreditation Council (NAAC). The Director placed on records special thanks to Prof. Sachidhanandham for his significant contribution in compiling Self Study Report (SSR) which the University has recently submitted to NAAC for accreditation

It was emphasised by the Director & Coordinator that the IQAC team should meet at regular intervals to deliberate upon various proposals for improving the content and structure of B.A. LL.B (Hons.) Programme.

Some of the points which were deliberated upon included:

- Director & Coordinator, IQAC informed the members of IQAC that the Vice-Chancellor, NLU Delhi has appointed a Curriculum Review Committee and its report may be discussed at IQAC.
- It was emphasised that a sub-committee could be formed to deliberate upon the following matters:
 - a. To identify core and non core courses in the curriculum of B.A. LL.B (Hons.) Programmes

- b. To identify more market oriented courses which could be incorporated in the curriculum of B.A. LL.B (Hons.) Programme.
- c. To identify a scheme for spreading the courses such as Environmental Law over two/three semesters
- d. To identify more electives / optional courses which could be incorporated in B.A. LL.B (Hons.)
 Programme.
- e. To introduce those seminar courses that supplements the core law subjects.
- f. Currently the University offers 50 core courses (5 courses per semester) in B.A. LL.B (Hons.) Programme. The sub-committee shall also make recommendations for introducing one or two more courses in each semester
- g. The sub-committee to evaluate the desirability of the project work for all courses and also the weightage of marks of project work to total marks of each course
- h. The sub-committee to deliberate upon logical sequencing of the courses in B.A. LL.B (Hons.) programme
- 3. It was agreed by the members of committee that Honours Programme should enable the students to specialize in certain fields of law and the it was decided that the same may be deliberated upon by the sub-committee
- 4. It was agreed by the members that some representatives of UG Council could also take part in IQAC meetings.
- 5. The following issues which are being faced by the University in clinical programmes were also discussed:
 - a. Issue of Documentation and Reporting with respect to clinical programmes
 - b. Problems associated with field work
- 6. In due course of time Credit Based Choice System (CBCS) might become mandatory and it was suggested that University may start preparing itself for implementing the same
- The sub-committee to deliberate upon the above mentioned points and make recommendations to IQAC.
- 8. The next meeting of IQAC will be held in the month of August 2015

The meeting ended at 1:30 p.m. with a vote of thanks by Director & Coordinator
