**INTERNATIONAL VISITORS
PROGRAMME**

National Law University Delhi (NLU Delhi) is committed to fostering collaborative academic engagements and enhancing mobility of students, researchers and faculty. Building and sustaining international academic collaborations (both legal and interdisciplinary) is vital to achieving our vision of becoming a leading global university through excellence in research and learning. In pursuance of this goal, NLU Delhi has instituted the International Visitors Programme, which is designed to facilitate interaction and collaboration with scholars from leading institutions across the world.

Objectives of the Programme

The programme is designed to enrich the academic and research ecosystem at NLU Delhi through interactions with outstanding international scholars. In particular, the programme will:

- a. Offer opportunities to international scholars to develop their research and explore innovative ways of engaging with NLU Delhi faculty and students in a vibrant and learning environment including offering niche courses;
- b. Promote greater academic and research links with institutions and individuals across the globe;
- c. Provide opportunity to NLU Delhi faculty and students to benefit and learn from scholars working on a wide range of research interests; and
- d. Explore possibilities of joint ventures and projects.

The University welcomes applications for the programme from:

- a. Academics holding full time position in their institutions;
- b. Professionals/practitioners with over 7 years of industry experience

There is however a limit on the number of available places and priority would be given to scholars from partner institutions of the University.

Categories of International Visitors:

NLU Delhi has the following visitor tracks:

- 1) Visiting International Scholars;
- 2) Visiting International Researchers; and
- 3) Visiting International Professionals/ Practitioners

I. Visiting International Scholars

Full-time faculty and researchers in colleges/ universities located outside India can apply to be Visiting International Scholars at NLU Delhi. Scholars from fields other than the law whose work has strong interdisciplinary connections with the law are also encouraged to apply. While pursuing their own research, Visiting International Scholars are expected to contribute to enriching the academic environment at NLU Delhi.

Application Requirements:

- a) CV (with academic publications as a necessary part).
- b) Full text of the three latest academic publications in peer reviewed journals or book/ chapters in an edited volume with reputed academic publishers.
- c) A statement of purpose (no more than 500 words) that includes the proposed duration with specific dates. The duration has to be at least one month and no more than one year. We would prefer applicants to identify periods that coincide with our academic semester indicated below.
- d) A research and engagement plan for the proposed duration at NLU Delhi (no more than 1500 words).
- e) A letter of support from the head of the institution confirming that the applicant is a full-time member or employee (or equivalent) associated with the institution, and that the proposed visit has their full support.

Potential Avenues for Engagement

- a) Engagement with faculty members and relevant research centres at NLU Delhi to build on the Visiting International Scholar's academic work and research interests.
- b) Periodic faculty seminars for presenting their work.
- c) Engagement with students through seminar courses (40-45 hours in a semester) or short-term courses.
- d) Special lectures in compulsory courses that are part of the B.A., LL.B (Hons.), LL.M and doctoral programmes.
- e) Short-term research collaboration with faculty members/ research centres at NLU Delhi.
- f) Participation in all events/ workshops/ training programmes at NLU Delhi.

Facilities

- a) Visiting International Scholars will be provided with office space in the University along with all necessary IT infrastructure.
- b) Full access to the library and electronic resources subscribed by the University along with remote access for the proposed duration.
- c) Subject to availability, accommodation in the University Guest House can be provided on the payment of relevant charges (free of charge only if the International scholar's visit is being financially supported by NLU Delhi).

Academic Sessions

The academic year at NLU Delhi has two semesters:

- a) Early August to Mid-December
- b) Early February to Mid-June

Funding

- a) Fully supported positions (two positions per academic year for the category of international scholars): NLU Delhi will offer up to two fully funded positions per academic year. The programme will cover round trip international air travel (economy class), including visa costs, from the place of visitor's residence to New Delhi. The Visitor will receive free boarding and lodging at NLU Delhi.
- b) Partially supported positions (two positions per academic year): NLU Delhi will offer up to two partially funded positions per academic year. The Visitor will receive free boarding and lodging at NLU Delhi, but will be required to make their own travel and related arrangements.
- c) In assessing application for funding, NLU Delhi will consider:
 - i) The body of work by the Visiting International Scholar as evidenced in the CV.
 - ii) Impact of the Visiting International Scholar's work as reflected in the CV.
 - iii) Statement of purpose that forms part of the application.
 - iv) Research/ engagement that forms part of the application.
 - v) Benefit to NLU Delhi community/Relevance for NLU Delhi community
- d) Self-funded positions: NLU Delhi welcomes international scholars in receipt of international fellowships (such as Fulbright Fellowships, etc.) to spend time at NLU Delhi under the International Visitors Programme.

Duration of visit: One to Three Months or as may be mutually agreed.

II. Visiting International Researchers

- a) Full-time or part-time Ph.D/Post-Doctoral scholars registered in any foreign University shall be eligible to be a Visiting International Researcher at NLU Delhi.
- b) Ph.D/Post-Doctoral scholars can be from any field as long as they are able to demonstrate strong interdisciplinary relevance for the law.
- c) All the provisions above applicable to the Visiting International Scholars programme shall be applicable to Visiting International Researchers with the following changes:
 - i) Visiting International Researchers shall be required to provide the full text of two publications as part of their application materials.
 - ii) There shall be no funding available from NLU Delhi for Visiting International Researchers.

- iii) Once selected, Visiting International Researchers shall work with a faculty member in the relevant subject area to implement their research/ engagement plan at NLU Delhi.
- iv) Office space cannot be guaranteed for Visiting International Researchers but designated spaces in the University library shall be provided.

Duration of visit: One Month

III. Visiting International Professionals/ Practitioners

- a) Professionals and practitioners in any field with at least seven years of demonstrable experience (not limited to the legal field) shall be eligible to be a Visiting International Professional/ Practitioner at NLU Delhi.
- b) Professionals and practitioners in fields that have a strong interdisciplinary relevance for the law are also encouraged to apply.
- c) Application materials as outlined above must clearly indicate a strong track record of engagement with the law either from a legal or interdisciplinary perspective.
- d) Applicants for the Visiting International Professionals/ Practitioners are not required to provide a publication as part of their application materials.
- e) Selected Visiting International Professionals/ Practitioners shall work with a faculty member in implementing their approved research/ engagement plan at NLU Delhi.
- f) All other provisions above applicable to Visiting International Scholars shall be applicable to Visiting International Professionals/ Practitioners as well.
- g) Subject to the decision of the Vice Chancellor, NLU Delhi shall not provide any funding to Visiting International Professionals and Practitioners.

Applying to become an International Visitor

Individuals who wish to apply for the International Visitors Programme must complete the [application form](#). The application can be submitted at any time of the year, but must be made atleast 4 months prior to the proposed commencement of the visit. In order to be eligible for the programme, the visit must be for atleast one month.

Application does not guarantee acceptance. The completed form and supporting documents would be considered by a committee constituted by the Vice Chancellor, NLU Delhi. All applications would be reviewed on a wide range of considerations including scholarly merit, practical value, engagement with contemporary concerns, uniqueness of the contribution and relevance to University's teaching and research. A decision on the application would normally be communicated within 4 weeks of making the application. A formal invitation would be extended to successful applicants along with relevant information regarding the visit (category, duration, allowed activities, etc) and a general visitor agreement. The University is not in a position to provide detailed feedback on unsuccessful applications.

Roles and Responsibilities

Visitors are encouraged to participate and contribute to the academic and research life of the University. The programme is designed for scholars intending to work independently with minimal supervision. All visitors are responsible for their work and research while at NLU Delhi.

International visitors are expected to refrain from engaging in additional assignments during their time at NLU Delhi. Visitors are not permitted to register as a student, work towards a qualification, undertake paid work or stay beyond their visa validity.

Duration of the visit

Visits under the programme can range from one to three months. However, the proposed learning and research engagements must match the proposed duration.

Applicants are strongly encouraged to plan their visit to coincide with at least part of the academic semesters.

Funding support and other logistics

NLU Delhi does not provide salary, stipend, or other payments. Visitors will ordinarily be required to demonstrate that they have the necessary funds to cover the costs of their visit. Subject to availability, accommodation in the University can be provided on the payment of relevant charges.

All visitors must obtain appropriate visa before coming to NLU Delhi. The University will provide necessary documents in support of the visa application.
