- In case if the lost/damaged book is not available with the vendor/publisher, the borrower shall be liable to pay two times(double the cost)of the books with the fine applicable.
- Borrowers shall keep the books in good condition. Making marks with pen/pencil, tearing of taking out pages of book or spoiling the book will amount to causing damages to the book.
- Duplicate membership/Library cum Identity card will be issued @Rs. 100/- on production of First Information Report (FIR) copy.
- In case of failure to return issued books/library documents, the authority may take appropriate action.

DUES CERTIFICATE FOR DISCONTINUING LIBRARYMEMBERSHI

• Students/faculty members shall be requiring clearing their dues from the library at the time of leaving the University. No dues certificate will be issued by the library only after returning of issued library documents /paying dues if any by students/faculty members along with Library cum identity card.

GENERAL REGULATIONSS AND REGULATIONS

- Library is open to bonafide members only.
- Every member who enters the Library shall sign the visitor register.
- The entire library is under the CCTV surveillance system.
- Members should produce their Library Cum ID card for borrowing library documents.

- Mobile Phones are not allowed inside the Library.
- Except Laptops, no personal books, bags etc. are allowed inside the Library.
- Do not keep money or valuables in bags. Library staff will not be responsible for any loss.
- Library staff may request any user to leave the premises if found to be violating any of the Library Regulations.
- Any Violation of the NLUD Library Regulations shall lead to forfeiture of the membership of concerned member.

Lending/Circulation

- Students should produce their Bar-Coded Identity Card for all transactions in the Library documents.
- The user shall get the document issued from the circulation counter.
- The user shall be responsible for loan documents issued on his/her account. The document(s) issued on individual accounts is non-transferable.
- No library documents shall be issued during vacations.
- Books on Loan shall be returned on due date from date of issue.
- · Identity-cum-Library Cards are non-transferable.
- Books/Documents from reference collection shall be issued on special permission.
- Renewal of books will only be done if not reserved by other members.
- Books can be renewed twice for three days in case of no reservation.
- Library document /book on loan could be recalled before due date of return.

OVERDUE CHARGES

- The borrower of the library books would be liable to pay fine as per given below:
- The overdue charges for first fifteen days are Rs. 2/- per day.
- Between fifteen to sixty days the overdue charges will be Rs. 3/- per day.
- Above 60 days the charges will be Rs. 10/- per day.
- The request for waiving or reducing of fine in special circumstances shall be the discretion of the Vice Chancellor.

Library Services and Facilities

Justice T.P.S Chawla Library is committed to support higher education and fulfill its mission by providing dedicated services to its clientele. Its services constitute dealing with the following assistance activities to its patterns. The library provides both anticipatory and responsive reference services from professional librarian to the users for maximum utilization of library sources and also advice on the usage of library collection.

Access Services

The Library offers circulation services to its patterns. It includes providing borrowing facilities, reservation of library document, collection of fine, no due certificate, re-shelving of library documents.

Current Awareness Services

The contents of the LII of India prototype contains 154 databases including legislation (the India Code from 1836, some State legislation, and commentary on legislation), Indian case law (over 300,000 cases in full text from the Supreme Court, most High Courts, and tribunals), treaties (all India treaties to 1975, plus many subsequent bilateral treaties), law reform reports (from the Law Commission), legal scholarship (six law journals to date, with scholarship repositories, books and judicial scholarship still to be developed), cases concerning India in International Courts and Tribunals, and cases concerning India from the pre-1873 English Reports.
