The University has been recognized by the Bar Council of India under Section 7(1)(i) of the Advocates Act, 1961 and has been granted approval to conduct the five-year integrated B.A.LL.B. (Hons.) Programme. The University has also been included under Section 12(B) of UGC Act 1956. The University has been established with a mandate to create lawyers who are professionally capable, socially responsive and equipped to face the myriad challenges of an ever-evolving society.

The vision of the University is to create a global legal institution which strives to be the best, both within as well as outside India, and to present individuals with a wide range of opportunities to contribute to the legal profession. NLU Delhi Ranked 2nd in NIRF for past 3 years

National Law University Delhi has been ranked 2nd all over India, in the Law Category of National Institute Ranking Framework (NIRF) 2018, 2019 and 2020 three years in a row.

This recognition was awarded by Ministry of Human Resource Development (MHRD), Government of India. On April 8, 2019, NLU Delhi upheld its last year's position, scoring 76.23 in 2019, progressing from 74.58 in 2018, almost eclipsing over the first ranker with 77.21. Almost 100 institutions participated in the Law category, were assessed on five parameters. For the last three consecutive years i.e. from 2018 till 2020, NLU Delhi pioneered in various ranking parameters for the universities, viz. Teaching, Learning and Resources (TLR) and Research Productivity, Impact and IPR (RPII).



National Assessment Accreditation Council (NAAC)

The National Assessment Accreditation Council (NAAC) has accredited the University with 'A' Grade with a benchmark CGPA of 3.59 on 4-point scale. The University has also been granted Category-I status by UGC for graded autonomy. These excellent ratings place NLU Delhi among few of top institutions in the country imparting quality legal education also reflects the excellent academic environment and governance at the University for teach and research.

PROGRAMMES

B.A.LL.B. (Hons.) PROGRAMME

NLU Delhi offers the Five Year Integrated B.A.LL.B. (Hons.) Degree programme. Candidates who have passed the Higher Secondary School Examination (10+2) system or an equivalent examination thereto securing in the aggregate not less than 45% of the total marks (40% in case of SC/ST/Persons with Disability). NLU Delhi conducts All India Law Entrance Test every year. The Eligibility condition for admission of students under the Foreign Nationals Category shall be 65% marks in the Higher Secondary School Examination of (10+2) system or an equivalent examination.

Candidates appearing/awaiting results of the qualifying examination can also apply and appear in the Entrance Test. However, the eligibility by such candidates shall have to be obtained by the cut-off date, which will be notified along with the Notification of Entrance Test result and in case such candidate is placed in compartment in the year of the admission, would be treated as ineligible.

Foreign National Candidates are exempted from taking All India Law Entrance Test (AILET). The other regulations regarding the eligibility for admission will be the same as applicable to the other candidates. The candidates belonging to OCI/PIO category shall have the option to apply either under the Foreign National category or under the category of Indian students. In case the OCI/PIO candidates apply under the category of Indian National, they have to appear in the All India Law Entrance Test along with other candidates. The Programme has 123 seats for all categories. For categorization and reservation of seats, criteria involved in conducting of All India Law Entrance Test-2021 AILET-2021, fee structure, and other important instructions, please [click here](#).

LL.M. PROGRAMME

The University offers LL.M. Programme in full time regular mode with number of specialization. To be eligible to appear for admission to One year- LL.M. Programme, a candidate should have passed the LL.B or an equivalent degree from a recognized University with not less than 50% marks in aggregate (45% in case of SC/ST/Persons with Disability category).

Candidates appearing/awaiting results of the qualifying examination can also apply and appear in the Entrance Test. However, the eligibility by such candidates shall have to be obtained by the cut-off date, which will be notified along with the Notification of Entrance Test result, and in case such candidate is placed in compartment in year of the admission would be treated as ineligible.

Foreign National candidates are exempted from taking the All India Law Entrance Test-2021 (AILET-2021). The Programme accommodates 70 students. LL.M. PROFESSIONAL

The University offers a specialized LL.M. Professional Degree. The objective of the LL.M (Professional) Programme ["LL.M (Pro)"] is to enrich academic excellence in professional services. Obtaining LL.M (Pro) will not qualify a candidate for academic (and other) jobs that require a LL.M as a minimum qualification. It will also not qualify a candidate to appear for the UGC's National Eligibility Test or similar tests.

The LL.M (Pro) programme will be a Master's programme through a mixed mode of distance education and contact learning. A person who has completed his/her graduation, in any discipline, with a minimum of 50% marks and has been in service, or has had professional experience for at least three years will be eligible to enroll for the programme.

The students currently enrolled in the LL.M., Ph.D. or any other programme at NLU Delhi shall not be eligible to apply for the LL.M. (Pro.) programme. Ph.D. PROGRAMME

The University offers doctoral degree programme in Law. To be admitted to the candidature for a doctoral degree an applicant shall have a Master's degree in Law or a professional degree declared equivalent to the Master's degree in Law by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting, or assuring quality and standards of educational institutions.

A foreign national, who is interested in enrolling for the Ph.D. programme at NLU Delhi, may apply in accordance with the admission notifications of NLU Delhi. The number of seats available for Ph.D. programme is notified by NLU Delhi every year before the start of admission process keeping in view the availability of teachers for guiding Ph.D. candidates.

Ph.D. programme is open for professionals in other fields subject to stipulated conditions and eligibility. DIPLOMA COURSE IN LAW AND PRACTICE OF ARBITRATION

ONLINE DIPLOMA COURSE ON INSOLVENCY AND BANKRUPTCY: LAW & PRACTICE

CTCL is inviting applications for its flagship Online Diploma Course on "Insolvency and Bankruptcy: Law and Practice". This one of its kind course aims to introduce legal and secretarial practitioners and students to the insolvency laws in India as conceptualized within the larger family of commercial laws including corporate laws, security transaction laws and recovery laws. The minimum eligibility for applying for this programme is a graduate degree (in law or other field) from a recognized university. Students in the 4th and 5th year of 5 years integrated law course or in the final year of 3 years LLB degree can also apply.

Students with a degree certificate or its equivalent from any UGC-recognized university, Association of Indian Universities, CA, CS, ICWA, Open University/distance learning can apply. There shall be no restriction as to age, nationality, and gender or employment status in the admission process. THREE MONTHS ONLINE CERTIFICATE COURSE ON BUSINESS AND COMMERCIAL LAWS

The Three Month's Certificate Course on Business and Commercial Laws will cover fundamentals of important business and commercial laws. The definition of 'commercial dispute' provided by the Commercial Courts Act, 2015 has been considered for the purpose. The course will provide knowledge about relevant substantive laws, procedural laws and train the lawyers for litigation in commercial courts. A special module for litigating in e- courts has also been included in the course. The course provides an opportunity of continuing education for lawyers and other relevant professionals.

RHODES SCHOLAR

The University, through the Legal Services Committee, has been involved in fostering legal aid and awareness. The University has established a fully functional Legal Aid Clinic and the Clinic for Assistance in Labour Laws (CALL) - an initiative to bridge the chasm between workers and the legal machinery, by providing access to quality legal aid. As a part of the HSF Community Engagement Awards, the initiative was selected as one of the five best legal aid initiatives in India. The University, through the Committee, has also constituted a pro-bono panel of practicing lawyers who help the committee in its legal interventions.

Gender Circle

The Gender Circle has played a prominent role in breaking gender stereotypes and creating gender sensitization on campus through various formal and informal interactive events, guest lectures and panel discussions

Ambedkar Periyar Phule Study Circle

This is a student-led initiative extending support in academics to marginalized students in the University, especially those who are unable to utilize academic opportunities due to various social barriers and constraints. It also acts as a platform for discussion and debate on the issues of social justice, gender, caste, race and other contemporary issues in India through guest lectures, panel discussions and movie screenings.

- **Criminal Law Reform Committee, 2020:** The Ministry of Home Affairs, Government of India in 2020, constituted a Committee for Reforms in Criminal Laws under the Chairpersonship of the Vice-Chancellor, National Law University Delhi. The Committee endeavours to recommend reforms to ensure the safety and security of the individual, community and the nation based on the constitutional values of justice, dignity and the inherent worth of the individual.

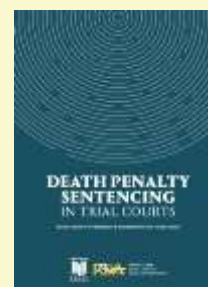
Annual Statistics 2020



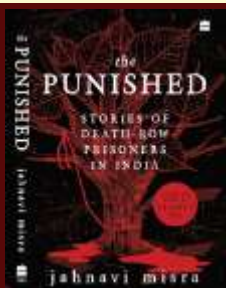
Since 2016, Project 39A at the National Law University Delhi annually releases a death penalty statistics report. The report covers movements in the death row population in India as well as political and legal developments in the administration of the death penalty and the criminal justice system. As on 31st December 2020, 404 prisoners are on death row in India.

Trial Court Sentencing Project

Death Penalty Sentencing in Trial Courts: Delhi, Madhya Pradesh and Maharashtra (2000-2015) contain findings from a study of all capital cases decided by trial courts of Delhi, Madhya Pradesh and Maharashtra between 2000 and 2015. The Report combines empirical analysis and doctrinal critique. Substantial parts of the report are dedicated to demonstrating the normative and procedural gaps in death penalty sentencing framework that have been the legacy of the Bachan Singh judgment and the numerous inconsistencies in Supreme Court judgments in 40 years thereafter.



The Punished



'The Punished' is a collection of short stories on death row prisoners and their families. It is based on interviews conducted by Project 39A with death row prisoners and their families, which later became the foundation for the Death Penalty India Report, 2016. Written by Jahnvi Misra, 'The Punished' explores the death penalty not from a legal lens, but from a human perspective.

Facets of Corporate Governance and Corporate Social Responsibility in India

The book analyzes the legal and social aspects of corporate governance in the Indian context. It takes into account internal and external factors that affect the sustainability of companies, such as stakeholder engagement, corporate social responsibility and role of government. It covers jurisdictions beyond India as well as a wide array of corporate governance issues. Prof. (Dr.) Harpreet Kaur, Professor, National Law University Delhi is the Editor of the book published by International Publishing House Springer in 2021.



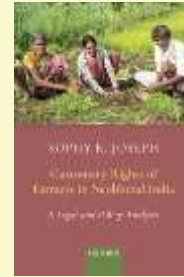
Reforms in Legal Education and Research

The University is fully residential and maintains separate residence for boys and girls. The Halls of Residence are provided with common room facilities, indoor games, like TT, Pool Table, Television and a State of Art Gymnasium. Management and maintenance of discipline in the halls of residence is the responsibility of the residents, Chief-Warden, Wardens and Assistant Warden. The residents have to mandatorily conform to the rules and regulations of the University.

TRANSPORT FACILITIES

The University also has two Innova Cars and a bus which is used for the student's activities such as court visits, Legal Aid Programmes and Clinics. The University is very well connected through Metro Rail and has good DTC bus services.

MEDICAL CENTRE AND AMBULANCE

The university has a 24 hours medical room with a nurse. A doctor visits the campus from 4-6 p.m. every day. Ambulance is also available round the clock for the residents of the University to deal with any emergency situation.

BANKS

National Law University Delhi has banking extension facilities through UCO Bank and HDFC Bank. Students may avail banking services on demand by contacting banking authorities. The University also has HDFC ATM machine installed in the Cafeteria.

SPORTS/GAMES

The facilities for sports are planned in the additional land which will be available to the University for the purpose, shortly. At present the university has a basketball, volleyball courts, badminton court and state of art gymnasium with the latest equipment for boys and girls in their respective halls of residence.
