Terms and Conditions:-

1. 4. Copy of valid Government Department Contractor licence such as CPWD, DJB
5. The work shall be carried out as per the directions of the Consultant (Technical)/AE
6. Certificate by the Agency that “I have inspected the site and rates are quoted accordingly” is also to be enclosed.
7. The material shall be as specified in the bid document and got approved before supply at site.
8. The rate shall be inclusive of all taxes including GST etc. and nothing extra shall be paid on this account.
9. Time period for completion of work is 15 days from the date of issue of work order.
10. Works to be carried out as standard specification of DJB norms cleaning & maintenance of rain harvesting pits and submit the certificate.
11. Agency has to made complete precautions during the work avoid any type of poisonous effect in nearby area.
12. Any damage during the execution to be set right by the agency.
13. Before execution of the work agency should be intimated to the concern authority.
14. No T&P shall be issued by NLUD.
15. Necessary Statutory recoveries shall be made from the bill as per GCC Norms and as per CPWD.
16. If work is not completed within the stipulated period without justified reason {The justification shall be with the satisfaction of Consultant (Technical)/AE (Electrical)}, the order will be cancelled and EMD will be forfeited and no claim for any loss on this account shall be entertained.
