- 3. The vehicle is available for inspection from 11.00 AM to 03.00 PM on all working days.
- 4. No bidding firm/person will be allowed to withdraw its bid after opening of the bids.
- 5. The auction of the said vehicle will be governed by the following conditions:
 - a) The bidders are required to pay Earnest Money of Rs. 5,000/- (Rupees Five Thousand Only) for each vehicle in the form of Demand Draft drawn in favour of Registrar, National Law University Delhi.
 - b) Quotations received without Demand Draft towards Earnest Money will not be considered and shall be rejected.
 - c) The successful bidder will be required to deposit the balance bid amount by means of Demand Draft drawn in favour or Registrar, National Law University Delhi within three working days of the intimation about the successful bidder.
 - d) The delivery of the sold vehicle will be given only to the successful H-1 bidder after submission of documentary evidence in support of residential status (Voter ID, Aadhar Cart etc., in case of individual and Registration Certificate etc in case of firm.)
 - e) The auctioned vehicle will be removed by the successful bidder within three working days of depositing the bid amount at his own expenses from the location of the vehicle.
