**Call for Applications for Consultant (Designer) for Project 39A**

The National Law University Delhi ('University') is seeking to engage one 'Consultant – Designer' on a three (3) month contractual basis, for Project 39A. The consultant will be responsible for designing posters, social media post templates, website template, bags, badges etc. and a handbook for a workshop on mental health and the criminal law, to be conducted in December 2024.

**About the Organisation:**

Project 39A draws inspiration from Article 39-A in the Indian Constitution on equal justice and opportunity in the legal system. We work on issues specific to the criminal justice system, and undertake pro bono litigation, research and outreach relating to prevention of torture, legal aid, forensics, death penalty, and mental health and criminal justice (for more information on Project 39A, visit [www.project39a.com](http://www.project39a.com)).

**Responsibilities:**

The designer is expected to:

- A. Develop designs associated with the branding and communications aspect of the workshop like posters, social media post templates, registration brochure, website template, bags, badges etc. and other study materials.
- B. Develop and implement the design and visual language of the handbook.
- C. Create and work on graphics suitable for the handbook.
- D. Finalise the design and graphics for the handbook based on feedback and in coordination with the staff.
- E. Create a web version of the handbook.
- F. Suggest the printing specifications for the handbook that bring out the best product.
- G. Coordinate with the identified printer till the production and printing of the final handbook.
- H. Undertake any other work that may be necessary to produce the designed outputs.

**Qualifications:**

- A. Extensive body of work and experience as a graphic designer.
- B. Experience in publication design with ambitious production value.
- C. Undergraduate/graduate degree in design and allied fields from a reputed university

**Compensation:** Remuneration will be commensurate with qualifications and experience. The duration of the contract currently will be five (5) months. The contract may be terminated by the University before the completion of five (5) months or may be extended as required.
