Ranganathan's Five Laws of Library Science, established in 1931, remain profoundly relevant in the digital age, where information is increasingly accessed through digital platforms and AI technologies like ChatGPT. These principles, originally intended to guide the management of physical libraries, have evolved to offer valuable insights into the management and dissemination of digital information.
