NLUD Project Exemption Policy

This policy applies to students of B.A. LL.B. (V Year Degree Programme) and implements clause 7.6 (C) of the NLUD Academic and Examination Regulations (2023).

- 1. Any student may avail a project exemption in any subject (except clinical courses and seminar courses) for the following:
 - a.As allowed under the moot court policy under the direct supervision of the MCC faculty coordinator and duly approved by the Vice Chancellor.
 - b.As allowed by Faculty Coordinator (Director/In-charge of a Centre/Chair constituted by the University) and approved by the Vice Chancellor.
 - c.As allowed by any faculty member to seek research assistance for any research project/consultancy and approved by the Vice Chancellor.
- 2. The faculty member allowing the exemption shall be primarily responsible for implementing this policy in respect of students being exempted by them. The selection of students under clause (1) shall be based on MCC policy or any other objective and transparent internal policies of centres /chairs or individual faculty members. There shall be no requirement for any faculty member to formally consent to a grant of a project exemption (i.e. project exemption sought in lieu of a particular subject).
- 3.All such duly approved exemptions must be conveyed by the faculty in-charge to the examination department within 10 days from the commencement of the academic session. A digital copy of the list shall be sent to Submissions NLUD submissions@nludelhi.ac.in containing the following information.

4. Students availing exemption under 1 (b) and I (c) of this policy shall be assigned only research work. Any administrative work/data entry or event organization shall not qualify for a project exemption. At least one such substantive research assignment shall be assigned to qualify for an exemption for per subject.

5. A student can avail only up to two project exemptions during a semester under 1(a), (b) or (c) of the policy. Students in 1st Semester cannot avail the benefit of this policy as they are governed by Rule 7.6(A) of the NLUD Academic and Examination Regulations (2023). Students in the final Year B.A. LL.B. programme can avail only one project exemption each in the penultimate (IX) and final semester (X).

6. The examination department shall duly scrutinize and any student availing more than two exemptions in a semester shall be duly reported for disciplinary action. The final list of student availing project exemptions shall be duly circulated among faculty members within 15 days from the commencement of the semester.

7. Every centre/chair/faculty member under 1(b) and 1(c) shall grant only one such project exemption per student in a semester.

8. Any project exemption granted under this policy shall contain an oral and a written component within the range of 15-20 marks (written) and 5-10 marks (oral). In case of moot court exemption, the faculty evaluating the memorial shall be required to conduct an oral examination of the students apart from evaluating the written memorial (15 marks for memorial) and (10 marks for oral submission).

9. At the end of every semester (project/viva marks submission date as per annual academic calendar), the faculty coordinator shall submit a report in the following format.

Such moderation shall be done before the release of end-semester results.
