1. National Law University Delhi, Sector-14 Dwarka, New Delhi-110078 is proposing to dispose off one condemned University Vehicle Innova on “as is where is basis” Details of the said vehicle is as under:

2. Accordingly, sealed quotations are invited for the disposal of the aforesaid vehicle on the terms and conditions mentioned below. Person/Firms, who are interested to buy the above mentioned vehicle may submit their highest quotations in the enclosed proforma in a sealed cover addressed to the undersigned latest by 3.00 P.M. on or before 07.01.2025 in the Tender Box in the Meeting Room of Academic Block Building National Law University Delhi, Sector-14 Dwarka, New Delhi-110078.
3. The vehicle is available for inspection from 11.00 AM to 03.00 PM on all working days.
4. No bidding firm/person will be allowed to withdraw its bid after opening of the bids.
5. The auction of the said vehicle will be governed by the following conditions:-
 - a) The bidders are required to pay Earnest Money of Rs. 5,000/- (Rupees Five Thousand Only) for each vehicle in the form of Demand Draft drawn in favour of Registrar, National Law University Delhi.
 - b) Quotations received without Demand Draft towards Earnest Money will not be considered and shall be rejected.
 - c) The successful bidder will be required to deposit the balance bid amount by means of Demand Draft drawn in favour of Registrar, National Law University Delhi within three working days of the intimation about the successful bidder.
 - d) The delivery of the sold vehicle will be given only to the successful H-1 bidder after submission of documentary evidence in support of residential status (Voter ID, Aadhar Card etc., in case of individual and Registration Certificate etc in case of firm.)

- e) The auctioned vehicle will be removed by the successful bidder within three working days of depositing the bid amount at his own expenses from the location of the vehicle.
- f) The vehicle will be disposed off on “as is where is basis” and no guarantee for its worthiness or quality will be given by the Department.
- g) The successful bidder will also be responsible for getting Registration Certificate of the Vehicle transferred in his name at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
- h) The successful bidder will not be allowed to withdraw their bids, failing which the Earnest Money will be forfeited.
- i) EMD of unsuccessful tender shall be returned within two weeks of the award of contract to successful bidder.
- j) The Competent Authority reserves the right to accept or reject any/all of the quotations without assigning any reason.
