The Centre for Regulatory Studies invites applications for **two (2)** full-time Research Associate positions to support the e-gaming regulations research project.

KEY RESPONSIBILITIES:

The selected candidates will be responsible for:

2. Developing detailed reports, policy briefs, and academic papers based on the research findings.

5. Undertaking any additional responsibilities or tasks as may be assigned in furtherance of any project's objectives.
