## CHECK LIST FOR BIDDERS FOR SUBMISSION OF BIDS

1. The bidder should read all the instructions, items & conditions, contract clauses, nomenclature of items, specifications etc., contained in the bid document very carefully, before quoting the rates.
2. Rates must be filled both in words and figures. Amount should be worked out for all the items.
3. The bidder shall quote his rebate if required, mentioning specifically on what component it is applicable otherwise it shall be considered general rebate on total quoted rates.

### Similar work means "Supply of Gym Equipment against buyback".

1. The time allowed for carrying out the work will be 10 Days from the date of work order.
2. Earnest money in the form of Demand Draft (drawn in favour of "The Registrar, National Law University Delhi") must be deposited in the University in a separate envelope.

Bid/Tender documents submitted by intending bidders shall be opened only of those bidders, **who has deposited EMD** and other documents submitted, are found in order.

### 3. The bid submitted shall become invalid if:

1. The bidder is found ineligible.
2. The bidder does not deposit original EMD.
3. The bidder does not enclose all the documents (including GST registration and copy of Pan Card) as stipulated in the bid documents.
4. If any discrepancy is noticed in the submitted documents by the lowest bidder.
5. If a tenderer quotes nil rates against each item in item rate quotation or does not quote any percentage above/ below on the total amount of the quotation or any section/ sub head in percentage rate quotation, the quotation shall be treated as invalid and will not be considered as lowest tenderer.
6. The Registrar NLUD does not bind itself to accept the lowest or any other quotation and reserves to itself the authority to reject any or all the quotations received without the assignment of any reason. All quotations in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
7. The competent authority reserves the right of accepting the whole or any part of the quotation and the tenderer shall be bound to perform the same at the rate quoted.
8. The bid for the works shall remain open for acceptance for a period of **10 Days (10)** from the date of opening of bids. If any tenderer withdraws his quotation before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions quotation which are not acceptable to the department, then

the NLUD shall, without prejudice to any other right or remedy, be at liberty to **forfeit 50%** of the said earnest money as aforesaid. Further the tenderer shall not be allowed to participate in the re-tendering the process of the work.

9. This Notice inviting tender shall form a part of the contract document. The successful tenderer/agency, on acceptance of his quotation by the Accepting Authority, shall, within 10 days from the stipulated date of start of the work, sign the contract consisting of:-
  - a. The notice inviting tender, all the documents including additional conditions, specifications and drawings, if any, forming part of the quotation as uploaded at the time of invitation of quotation and rates quoted at the time of submission of tender/quotation and acceptance thereof together with any correspondence leading thereto.

### General Terms & Conditions

1. The agency is to submit earnest money of Rs.72,398/- (Rs. Seventy two thousand three hundred & ninety eight Only) in the form of Demand Draft in the name of Registrar, National Law University, Delhi along with the quotation.
2. The agency is to submit the **Technical Bids** and **Financial Bids** in separate sealed envelopes.
3. The successful bidder shall deposit the 5% of Performance Guarantee (P.G.) of the tendered amount and may be released after successful completion of one year.
4. The agency should have minimum three year experience for supply of gym equipment to government organisations/institutions/universities and also attach the copy of work orders of the same.
5. The agency should be authorized original manufacturer (OEM) of Gym equipment. The manufacturer should also have service centre in Delhi NCR.
6. The agency should have the turnover of Rs.25.0 crore per annum during last three financial years. The turnover statement duly certified by Chartered Accountant should be enclosed.
7. The successful bidder has to supply the equipment(s) / good(s) within fifteen (15) days from the issuance of the purchase order. Failing which, the order can be cancelled by the establishment i.e. National Law University Delhi.
8. It is mandatory that, the agency/firm/ supplier shall possess registered office & service centre in Delhi NCR in connection with gym equipment's like dumbbell, plates, benches and machines illustrated at Annexure-I. The agency/firm/ supplier has to submit the scan copy of proof otherwise bids/tender will treated cancelled.
9. The supplier (s)/ bidder(s) have to supply the gym equipment(s)/ good(s) according as per Annexure-I.
10. All shipping, commissioning and installation fees shall be inclusive.
11. Cutting and overwriting in the quotation are not allowed. If, there is cutting and overwriting such quotation will not be entertained.
12. The agency is required to submit its bids/quotations on their letter head. The University is not bound to accept the lowest bid.
13. Copy of PAN card is to be enclosed.
14. Copy of GST Registration certificates is to be enclosed.
15. Registration certificate as per existing norms (indicating the legal status-company/partnership firm/proprietorship concern etc.) to be enclosed.
16. In case the supplied items are not according to specifications order will be cancelled.
17. The agency/firm/ supplier should be manufacturer/ franchisee/ authorized dealer. In this regard, please attach scan copy of requisite document/ proof.
18. No manpower will be provided by the University for Loading and unloading the goods/material.
19. The bids/tender received after last date and time of submission will not be entertained.
20. The conditional tenders /bids would not be accepted.
21. If it is found, that the supplied items are not satisfactory and as per requirement, the university have rights to cancel the order and no payment will be made.
22. The university has reserved the rights to cancel the quotation/tender without assigning any reason/ notice.
23. Bidder's offer is liable to be rejected if they don't upload and fill the check list (annexure-III) any of the certificates/ documents sought in the Bid document, Additional Terms & Condition, if any
24. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.
25. If the agency is registered under MSME or NSIC, then EMD exemption certificate needs to be enclosed.
26. List of Buyback items at Annexure - II
27. Transportation of buy back items from buyer premises shall be arranged by the seller itself without any extra cost.



28. Government Buyer organization /consignee will issue invoice of buy back items to the seller at the cost of buyback to be indicated to the buyer by the seller offline after receipt of order. This in no case will modify the bid in any manner.
29. The seller will be entirely responsible for the safe disposal of old items without affecting the environment in any manner as per prevailing statutory rules and Act/ law of the land.
30. The seller may visit the site and inspect the condition of buy back items in advance before quoting for the bid. (List of Buyback items at Annexure –II). The proposals without buyback will be rejected summarily.
31. Receipt of payment by the buyer for Old items and invoicing by buyer will be out of tender.
32. If the minimum price (Optional) is indicated and sellers of new item who are not agreeing to take back the old item at equal to or above that minimum price should not participate in the bid.
33. In case they participate into the bid and afterwards indicates the price of old goods, less than the minimum price shown by Government Buyer in corrigendum, EMD of the bidder will be forfeited.


