Eligibility & Course Structure



Candidates **must** be a Graduate in any discipline; In case of candidates enrolled in an integrated undergraduate course of **4/5 years**, they must be in the **4th or 5th year** of their course.



Duration

The classes are conducted online using a blended learning approach. This includes live lectures, discussion forums, recorded content, e-learning materials, and selfstudy hours. Classes are scheduled on Saturdays 6:00pm to 9:00pm.



The program is divided into six modules, delivered through a combination of one comprehensive diploma and multiple shortterm certificate courses.



Virtual sessions on Learning Management System (LMS). The method of teaching shall be of blended nature with online live lectures and content. Focus upon Building Skills with Drafting and Simulation exercises



Participants will be graded based on their participation in sessions and performance in continuous and summative assessments, including a final assessment. To earn the diploma, attendees must complete 75% of sessions and score a minimum of 50% in each assessment.

Courses Offered

The programme offers one comprehensive Diploma and six specialised Certificate courses. All courses are delivered fully **online**, with live sessions scheduled on **Saturdays (6:00 PM – 9:00 PM)**, supported by interactive content, recorded lectures, and self-paced learning modules.

Participants completing all the certificate courses will be awarded the Diploma. Those completing individual sub-courses will receive the respective Certificate.
