In reference with the advertisement dated 19.06.2025 regarding Coordinator (Legal aid Clinic) issued by the National Law University Delhi, the list of shortlisted candidates are enclosed herewith at Annexure A.

The University will conduct a written test for shortlisting of candidates illustrated in the Annexure A. Thereafter the qualified candidates may be called for interview. Final selection will be on the basis of interview only by the Selection Committee.

The test will consist of following components and will be of 250 Marks:

1. Legal Knowledge and application (50 Marks)

You will be presented with scenarios where you'll need to demonstrate your understanding of legal aid concepts, ethical standards, and practical application of the law.

2. Management and Organizational skills (50 Marks)

This section will evaluate your ability to plan, monitor, and assess the effectiveness of legal aid programs.

3. Teaching and Community Engagement (50 Marks)

You will be asked to discuss your approach to teaching law students practical legal skills including client interviews and drafting legal documents. In addition, you will need to propose strategies for engaging the local community.

4. General Legal Writing and Analysis (50 Marks)

You will be required to respond to a case study, offering legal advice on a scenario involving real-life legal issues that clients of the clinic might face. You should demonstrate your analytical skills and ability to provide clear, actionable legal solutions.

5. Personal Reflection (50 Marks)

Finally, you will have an opportunity to reflect on your personal motivations for applying for the role of Coordinator. This section allows us to understand your passion for legal aid, your commitment to public service, and how your background aligns with the values of the Legal Aid Clinic.
