<b>17. Multidisciplinary / interdisciplinary</b>	

The NEP committee at NLU Delhi consists of members from Law & Social Sciences background. The committee is diligently striving towards the successful implementation of the National Education Policy (NEP) to enhance the institution's academic excellence and overall educational experience. Keeping in mind the multifaceted elements of NEP, following measures are taken: - Innovative curriculum, teaching, and pedagogy reflect multi-disciplinary approach. A range of seminar/elective courses focusing on multidisciplinary and contemporary areas are also offered to students. The University also facilitates exposure to global concerns through international collaborations with foreign faculties. NLU Delhi has established the National Academy of Law Teachers, to promote teaching-learning methodology. This includes promoting excellence in teaching, advancing research in legal education, and contributing to the overall improvement of the legal education system. Allocating resources and infrastructure to support multidisciplinary research and education initiatives. Fostering partnerships and communication between departments to facilitate interdisciplinary projects and knowledge exchange. All students are offered with Clinical Course in Legal Aid which trains students in public service using law. Supporting innovative approaches to teaching and learning that transcend traditional academic boundaries and foster critical thinking and problem-solving skills. The University has illustrious 24 Research Centres to cater to diverse research and training needs of the legal academia cross-cutting with other disciplines.

#### **18.Academic bank of credits (ABC):**

NLUD is registered under the ABC as proposed in NEP 2020. For the implementation of the ABC, the Curriculum Development Committee at NLU Delhi has undertaken a significant initiative to revise our curriculum. This revision is aimed at facilitating the seamless implementation of the Academic Bank of Credits (ABC) for our students. NLU Delhi is already registered on NAD Portal and we have also started the registration of students on Academic Bank of Credits (ABC) portal, reflecting our commitment to progressive and flexible education. 100+ students have registered for ABC so far and rest are under process. An incentive scheme of extra credits policy is outlined for students to earn and deposit credits in their Academic Bank under ABC.

#### **19.Skill development:**

NLU Delhi is dedicated to enriching legal education through robust skill development initiatives. These efforts underscore our commitment to producing well-rounded, practice-ready legal

professionals. Key highlights of our skill development endeavours include: Providing students with hands-on experience through legal clinics, moot court competitions, and simulated law practices to enhance practical skills. Fostering strong research skills through comprehensive legal research and writing programs, enabling students to analyze and articulate legal issues effectively. Offering training in alternative dispute resolution techniques and negotiation strategies to equip students with conflict resolution skills. In-Clinic I (ADR), students must undergo negotiation and mediation exercise which helps in learning the fundamentals and processes of ADR. In Clinic II ('Legal Drafting'), students are given fact situations and asked to draft, among other documents, complaints, bail applications, and bail orders. In Clinic III ('Legal Aid'), requires students to conduct empirical research that aids marginalized communities. In Clinic IV ('Trial and Appellate Advocacy') highlights the significance of advocacy skills and professional ethics and their inculcation in students. Students are also exposed to mooting, alternative dispute resolution, and client counselling exercises. Inculcating ethical values and professional conduct standards to ensure students uphold the highest ethical principles in their legal practice.

**20.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

Currently, University provides the law subjects like jurisprudence, HLCD integrating the Indian knowledge system in legal education. The University is further developing the courses on Ancient Legal System. This integration is manifested through a holistic approach that encompasses teaching in Indian languages, cultural awareness, and the utilization of online courses. Key highlights of this initiative include: Recognize the value of teaching in Indian languages, promoting linguistic diversity and making legal education more accessible to a broader spectrum of students. By instilling cultural awareness and inclusivity in our curricula, we ensure that our students appreciate the rich cultural tapestry of India and its impact on the legal landscape. Leveraging the power of online courses, for students to access educational resources and engage with a wide range of perspectives, including those rooted in the Indian Knowledge System.

**21.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

NLU Delhi places a strong emphasis on Outcome-Based Education (OBE), reflecting our commitment to producing graduates who are

well-prepared for the real world. Key highlights of our OBE approach include: A number of new outcome-based diplomas, certificates, LLM (Pro) and other vocational programs are floated regularly for keeping with the dynamic business environment. NLU also offers multiple seminar courses to students in their penultimate and final years that would allow them to better understand the practical application of law while approaching different legal issues with a more advanced and nuanced approach. Our programs are designed with clearly defined learning outcomes, ensuring that students understand what is expected of them and what they will achieve. Continuous assessment and evaluation, enabling us to track students' progress and adapt teaching methods to enhance their learning experiences.

## 22.Distance education/online education:

NLU Delhi is actively engaged in expanding its efforts toward Online Learning, recognizing the evolving landscape of education and the growing demand for flexible and accessible learning options. Key highlights of our initiatives in this domain include: The University runs several programs which are delivered to learners in Online/ Blended and on-campus modular mode. The NLU library is supported by diverse online databases which provide ready and quick information to the students. It provides remote access that allows its students and faculty to make use of legal databases and use the library for research purposes from anywhere in the world by simply logging in. The Universities Massive Open Online Courses (MOOCs), E-content on e-PG-Pathshala, SWAYAM can be easily accessed by anyone, anywhere, and at any time free of cost. We also offer online diplomas namely: - Diploma in Law and Practice of Arbitration Diploma course in Insolvency and Bankruptcy: Law and Practice.

As a pre-eminent institution, National Law University Delhi is committed to imparting comprehensive interdisciplinary legal education with the objective to empower students in understanding and addressing contemporary challenges and developmental concerns.

To achieve this vision, the University's curricula at all levels (UG, PG and Ph.D.) are designed to reflect relevance to local, regional, national and global developmental needs.

- Mandatory courses offered by the university in "Civil Procedure Code, Criminal Procedure Code, Banking and Finance Law" deals with local and regional laws and their application in different jurisdictions.
- Courses on "Constitutional Law, Administrative Law, Environment Law, Human Rights Law, Law and Poverty" reflect national vision and concerns relating to various aspects of socio-economic development.
- Courses on "Public International Law, International Trade Law, and Intellectual Property Laws" foreground both regional and global discourse on developmental needs.
- Seminar courses offered to students of IVth and Vth year provides them the understanding of niche areas of law such as "International Criminal Law and Investment Arbitration".

The university invites both national and international external experts for conducting special lectures which address a range of developmental needs and concerns. The University has international exchange programmes and summer schools that facilitate multicultural exchange and collaborative learning.

The University envisions that legal education being imparted to students must be reflective of social challenges and concerns. To this end, the curriculum has integrated issues which are of relevance to Professional Ethics, Gender, Constitutional and Human Values, Environment and Sustainability, etc.

- Human and Constitutional values are promoted through courses on Constitutional Law, Administrative and Political Science which introduce students to Fundamental Rights and Duties. - The courses on Jurisprudence, Sociology and Family Law introduce students to nuances of gender roles and social

structure. The area of environment and sustainability is introduced to students through subjects like Environmental Law which provide students with an understanding of critical issues like climate change and biodiversity loss.

- In the area of Business Law, subjects like Company Law offers insights into Environmental Social Governance and gender dynamics.
- Professional Ethics is taught to students in the Clinic Courses.

The University offers specialised courses and adopts a multi-disciplinary approach to different subjects like environment, gender and ethics so that they are taught in an overarching and holistic manner to incorporate their cross-cutting nature.

## 2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

The University employs diverse student-centered approaches in its teaching methods, including lectures, seminars, and tutorials.

To promote peer learning, students are allowed to present projects to the entire class for feedback. Assignments and exams focuses on applying the law to hypothetical scenarios, emphasizing problem-solving skills.

The four mandatory clinical courses "Alternative Dispute Resolution, Legal Drafting, Legal Awareness, and Trial Advocacy" carry more credit weightage than regular courses, fostering experiential learning.

Seminar courses in the fourth and fifth year cover topics like climate change and criminology taught by experts globally. The "Buddy over Batches" (B-o-B) project assigns senior students to

guide newcomers aiding issue resolution in the initial stage, managed by the "Student Welfare Committee".

The University expeditiously processes applications for faculty promotion through the Career Advancement Scheme (CAS). The faculty members receive support for conference/seminar participation, with allowances for domestic events twice a year and international ones every two years, permitting a maximum one-week leave per semester, excluding vacation periods.

To encourage research publications, the Executive Council, as per item No. 3.6 dated 25.09.2021

(<https://nludelhi.ac.in/download/ssr/21.pdf>) has sanctioned Rs. 20,000/- financial incentive for articles in SCOPUS, Web of Science, or UGC Care-listed journals, and other prestigious legal and sociolegal journals.

The university provides Rs. 10,000 and Rs. 5000/- annually to each faculty member for book and stationery purchases respectively. University also financially supports various research centres being run by the faculty members.

University provides cashless medical services on Central Government Health Scheme (CGHS) rates for faculty and their dependents and offers a fixed monthly medical allowance for outdoor medical expenses. The University also grants academic leaves and sabbaticals as per prescribed UGC norms. The University has a designated medical centre with availability of doctors and nurse and medicines.

2.5.3 - IT integration and reforms in the examination procedures and processes (continuous internal assessment and end-semester assessment) have brought in considerable improvement in examination management system of the institution

To enhance the fairness and transparency of examination procedures the University has incorporated IT integration utilizing Turnitin—a plagiarism detection software through which students' submissions are received within specified deadlines. The examination department then transfers the files to respective faculty members via Google Drive for evaluation, excluding internal assessments.

Faculty members provide marks through an excel sheet which undergoes vetting and moderation. Final marks are then published and provided to the students in online as well as offline mode.

In February 2023, the following reforms were undertaken through

approval of University Bodies.

- All powers assigned to moderation committee to moderate results.
- UG members to be class teachers for better coordination.
- Declaration of final attendance status of the students along with the list of students eligible to appear in the examination. Attendance requirements to appear in examination aligned with 70% requirement of Bar Council of India.
- Request for re-evaluation to be submitted to the Convenor, CPGLS who shall place it before the Vice-Chancellor for necessary approval and appointment of a panel of examiners.
- Reforms in student academic leaves and medical leave approval.
- Mid-semesters compulsory paper will be 25 marks (5 marks are drawn from withdrawal of attendance marks policy).
- Removal of hall ticket provision and halls arranged based on list of debarred students; limiting special repeats to Vth year students only.
- Expansion of projects and what qualifies as projects; removal of debarment policy for non-submission of projects.
- Use of AI prohibited.

The university diligently designs its academic program curriculum, subjecting it to thorough review through CDC (Curriculum Development Committee) at the start of each academic session.

For LL.M. and Ph.D. Program, the University undertakes six-monthly Work-in-progress presentations keeping a track of the progress made to provide constructive feedback to the students on their submitted work. LL.M. students are required to submit the First and Second Status report before the submission of final dissertation. The outcome evaluation for LL.M. is based on the final dissertation and the end-term examination. For the Ph.D. students, it is evaluated through the course work undertaken in addition to their thesis work.

Clear communication of learning outcomes incorporating both theoretical and practical perspectives is prioritized for students. The university systematically gathers and assesses data on these outcomes, utilizing input from faculty, the academic committee, and an annual anonymous online survey that captures student feedback on faculty performance and course outcome fulfilment.

A range of continuous evaluation methods including internal assessments, mid-semester examinations, end term examinations, projects, presentations, and viva voce are implemented to oversee student performance and ensure the realization of course outcomes.

In acknowledgment of outstanding accomplishments the university awards various gold medals and cash prizes during the convocation ceremony.

**3.3 - Innovation Ecosystem**

3.3.1 - Institution has an ecosystem for Knowledge Creation, including Advanced Research Centre and other initiatives for the creation and transfer of knowledge

**Aim:**

Various instruments of incubation ecosystem building are applied at NLUD, beginning with seminars and conferences on legal entrepreneurship and long term legal research culminating into commercially viable solutions.

**Outcomes:**

- In 2022, we received the British Council exploratory grant to develop a course on Climate Justice and Climate Law with a focus on South-North perspective. The online summer course was offered in June-July 2022 to students across the globe.
- SOAS -NLUD partnership applied for a top-up grant to develop an advanced course on climate justice for professionals and students with a basic understanding of the climate discourse and is currently developing a Joint Master's degree in Environmental Justice.
- Centre for Communication Governance at NLUD attempts to ensure that the Indian legal education establishment engages more meaningfully with communication law and policy and offers academic contribution to communication policy making.
- Project 39A is inspired by Article 39-A of the Indian Constitution, Project 39A aims to trigger new conversations on legal aid, torture, forensics, mental health in prisons, and the death penalty.
- Centre for Labour Law Research and Advocacy and Centre for Innovation, Intellectual Property and Competition also are invested in ideas that bridge the gap between the academia and industry.

The University has an active Pro Bono Club that has conducted a range of activities in the neighbourhood community with significant engagement and impact. These community engagement activities have in turn enriched the experience and holistic development of students at NLU Delhi.

- In August 2022, the Club organised a legal awareness camp for 150 students of Govt. Sarvodaya Vidyalaya (Sector 13, Dwarka, New Delhi) on issues concerning the "Right to Equality" and "POCSO Act".
- The Club also reached out to very young school dropouts in the Bharat Vihar locality in Dwarka in August 2022 and motivated them on the "Importance of Education", "Fundamental Rights and Duties", and the "Nyaya Bandhu App" of the Dept. of Justice.
- In September 2022, through collaboration with the Dept of Justice, students of NLU Delhi were sensitised about the various access to justice schemes of the Dept. of Justice.
- In September 2022, the Club adopted the Kangan Heri village in the Kapashera Sub-Division of the Delhi South-West District towards conducting regular legal awareness camps and providing free legal aid.

The Club conducted a 5-day capacity building programme in October 2022 on 'Justice Education' for 100 students of NLU Delhi.

The University also has access of research software like SPSS; Turnitin; Drilbilt and Koha. The University maintains its intellectual research scholarships on DSpace based institutional repository known as "Vidhi Gyan Sangrah" facilitating access to its students and faculty members.

4.3.2 - Institution has an IT policy, makes appropriate budgetary provision and updates its IT facilities including Wi-Fi facility

The campus is fully wifi enabled. The internet center, which has fifty upscale desktop computers with optical drives and Microsoft operating systems, is housed in the library. There is a dedicated bay for laptop users. Three servers provide high-speed bandwidth and support for the internet center, which also has a print facility.

All classrooms have digital podiums, LCD projectors and display screens, and internet connectivity. In order to make the most of internet connectivity for study, laptop purchases are mandatory for students. Through MTNL, the University's campus has IGPS

connectivity as part of the MHRD, Government of India's NMEIET initiative. There is 200MBPS (Jio backup lease line) and 1GBPS (NKN) of available internet capacity. Auditorium has LCD projector, audio visual, WiFi-LAN, CCTV, and video recording facilities.

All classrooms have Smart e-Podiums, LCD projectors, audio-visual equipment, WiFi-LAN access, and video recording facility. There are LED screens, audio visual, WiFi-LAN, and video recording facility in the meeting rooms and moot court hall. The conference rooms provide video recording capabilities, audio visual, Wi-Fi-LAN, and LCD projectors. There is also a new Zoom license available for online instruction that is connected with the TCSION LMS Portal.

- Committee of the Equal Opportunity Cell, SC/ST Cell and Social Inclusion Committee are constituted for the benefit of the stakeholders.
