About NLU Delhi

Established in 2008 through the joint initiative of the Hon'ble High Court of Delhi and the Government of the National Capital Territory of Delhi, National Law University Delhi was founded with the vision of delivering comprehensive, interdisciplinary, and socially responsive legal education. It offers courses at both undergraduate and postgraduate levels and is built on the five-year law degree model, which is proposed and implemented by the Bar Council of India. The National Law University, Delhi Act, 2007 provides that the Chief Justice of India, or a senior judge of the Supreme Court nominated by him or her, shall serve as the Visitor of the University. The Act further designates the Chief Justice of the Hon'ble High Court of Delhi as the Chancellor, with the Vice-Chancellor functioning as the chief administrative authority of the University.

Over the years, the University has established itself as one of India's leading institutions for legal education and scholarship. NLU Delhi's strong commitment to academic excellence is reflected in its consistent performance in national rankings, placing second among law universities in the National Institutional Ranking Framework (NIRF) for seven consecutive years.

The University is dedicated to the dissemination of legal knowledge and its contribution to national development. Through rigorous academic engagement, research, and public-oriented initiatives, it seeks to enhance the capacity to analyse contemporary issues of public importance and their legal implications. These efforts foster legal awareness in the community and advance the broader goals of justice.



About the Chair

The Chair on Investment Treaties and International Commercial Arbitration at National Law University, Delhi, was established as a distinguished academic and research initiative under the patronage of former Supreme Court Judge, Hon'ble Justice Indu Malhotra, and the chairmanship of Mr V. K. Rajah, Vice President of the ICC Court of Arbitration. The Chair signifies NLU Delhi's resolve to cultivate informed discourse, professional excellence, and global engagement in the field of international arbitration.

The Chair is conceived at a time when international arbitration, both commercial and investment treaty arbitration, has assumed critical importance in global dispute resolution. Justice Indu Malhotra

Hon'ble Justice Indu Malhotra is a former Judge of the Supreme Court of India. Before her elevation to the Bench, she served as a Senior Advocate at the Supreme Court and, in 2007, became only the second woman to be designated as a Senior Advocate by the Court. In 2018, she created history by becoming the first woman to be elevated directly from the Bar to the Supreme Court. Justice Malhotra is the author of a leading commentary on arbitration law and practice in India, which has been extensively cited by the Supreme Court and various High Courts in several landmark judgments. She has instituted this Chair, intending to strengthen the capacity of government officials in addressing international disputes more effectively.

Mr. V. K. Rajah currently serves as Vice President of the ICC International Court of Arbitration. Over the years, Mr. Rajah has chaired tribunals and acted as arbitrator in numerous high-profile and complex international commercial arbitrations as well as investor-State disputes. From 2004 to 2014, he served as a Judge of the Singapore Supreme Court and was later elevated to the position of Judge of Appeal. In 2014, he was appointed Attorney-General of Singapore. Upon his retirement from public service in 2017, the Prime Minister of Singapore, in a valedictory letter, noted: "In every appointment, you have carried out your duties with dynamism and commitment. You have strengthened our legal system and made a lasting difference for future generations of lawyers."

Prof. Stavros Brekoulakis

Professor Stavros Brekoulakis is the Michael and Laura Hwang Chair of International Arbitration at the National University of Singapore. He practices as an arbitrator from 3 Verulam Buildings (Gray's Inn) and is consistently recognised as a Who's Who Legal Arbitration: Global Elite Thought Leader. He is the author of numerous monographs, books, edited volumes, and articles in leading law journals. He has been invited to deliver the 2026 Summer Course on Private International Law at the Hague Academy of International Law, serves as Vice President of the ICC Court, and is a member of the ICCA Governing Board. He also holds key editorial positions such as General Editor of the Journal of International Dispute Settlement and Deputy Editor of Arbitration International.



Ms. Carolyn B. Lamm

Ms. Carolyn Lamm is a Senior Partner at White & Case LLP and a prominent international arbitration practitioner. She was appointed by President Clinton to the U.S. Panel of Arbitrators for ICSID and later by the Government of Uzbekistan to the Uzbek Panel. She has represented several sovereign states in investment arbitrations and related litigation, including the Republic of Uzbekistan, the Russian Federation, and the Republic of India. She is a founding member of the American Uzbekistan Chamber of Commerce and currently serves as Chair of its Board. She has also served as President of the District of Columbia Bar, the American Bar Association, American Bar Endowment, and as the ABA's representative to the International Bar Association and the United Nations.



Mr. Toby Landau

Mr. Toby Landau KC is a senior Barrister and Arbitrator, and a member of the Bars of England & Wales, Singapore, New York, the BVI, and Northern Ireland, and registered in the DIFC. He practises in Singapore from Duxton Hill Chambers and London as a sole practitioner. He is a member of the Panel of Advisors to the Attorney-General of Singapore; Vice President of the SIAC Court of Arbitration; Member of the Governing Board of ICCA; Fellow of the CIArb and Chartered Arbitrator; Vice-Chairman of the Saudi Centre for Commercial Arbitration. He was a draftsman of the English Arbitration Act 1996. He holds a first-class law degree and a first-class BCL from Oxford University (Eldon Scholar), and an LL.M. from Harvard Law School (Kennedy Scholar).



Prof. N. Jansen Calamita

Professor N. Jansen Calamita is Principal Research Fellow, Centre for International Law, and Research Associate Professor (CIL), Faculty of Law, at the National University of Singapore. He is head of the Centre's programme on Investment Law and Policy. He has previously held academic positions at the University of Oxford, the University of Birmingham, and the British Institute of International and Comparative Law, and earlier served in the U.S. Department of State's Office of the Legal Adviser and the UNCITRAL Secretariat. He began his career in private practice in New York and has advised and trained more than two dozen countries across Africa, Asia, Europe, and the Middle East on foreign investment, commercial arbitration, and investor-state disputes. He has published widely in foreign investment and public international law, including *Investment Treaties and the Rule of Law Promise* (Cambridge, 2022), *ASEAN and the Reform of Investor-State Dispute Settlement* (Elgar, 2022), and the *APEC Handbook on Obligations in International Investment Treaties*.



Mr. Ciccu Mukhopadhaya

Mr. Ciccu Mukhopadhaya is a Senior Advocate with over 37 years of experience in legal practice and was designated as a Senior Advocate in 2011. He holds a Master's degree in Law from Temple University, Philadelphia, USA. He has served as Vice President of the ICC Court of Arbitration, Paris, for six years and regularly acts as an arbitrator in international and domestic arbitrations, including appointments by the ICC and SIAC, as well as ad hoc appointments as Chair, Sole Arbitrator, and Co-Arbitrator. He also has significant experience in corporate transactional and advisory work.



Mr. Promod Nair

Mr. Promod Nair is a Senior Advocate and dispute resolution specialist who regularly appears as counsel in commercial litigation and public law matters before the Supreme Court of India and various High Courts. He has been appointed as an arbitrator in proceedings under the LCIA, ICC, SIAC, and ad hoc arbitration rules. As counsel, he has conducted arbitrations across multiple jurisdictions in Europe and Asia under a range of institutional frameworks. He previously served as a member of the LCIA Court (2014–2019) and currently serves as a Council Member of the HKIAC.



Prof. Dr. Prabhash Ranjan

Prof. Prabhash Ranjan holds a PhD in Law from King's College London. He completed an intercollegiate LL.M. programme in London at the School of Oriental and African Studies (SOAS) and University College London (UCL) as a recipient of the prestigious British Chevening Scholarship. He is currently a Professor at O.P. Jindal Global University, Sonapat, a Visiting Professor at the National University of Juridical Sciences (NUJS), Kolkata, and an International Fellow at the National Institute of Military Justice, Washington, DC. Previously, he has taught at South Asian University, National Law University Jodhpur, and NUJS. He has also been a Visiting Scholar at Brookings India, a Visiting Fellow at the Lauterpacht Centre for International Law, University of Cambridge, and a Transnational Summer Law Institute Fellow at the Transnational Law Institute, Dickson Poon School of Law, King's College London.



Mr. Aditya Singh

Mr. Singh is a Partner at White & Case, Singapore, where he is part of the International Disputes and White-Collar Investigations practice. He is qualified to practise in India, New York, England, and Wales. He previously served as the first Asia Regional Chair of the Institute for Transnational Arbitration's under-40 group, Young ITA, and currently serves on the YSIAC Council. Mr. Singh is also an Adjunct Associate Professor at the National University of Singapore, where he teaches a course on International Arbitration. Before joining White & Case, he was a Student Empirical Research Fellow at Harvard Law School's Program on the Legal Profession, as well as a Grotius Fellow and Visiting Scholar at the University of Michigan Law School.



Mr. Ajay Thomas

Mr. Ajay Thomas is an ADR consultant and arbitrator with over two decades of experience in the field of arbitration. Most recently, he served as Registrar and Director of the Oman Commercial Arbitration Centre in Muscat. He has worked with three of the world's leading arbitration institutions (the LCIA, SIAC, and SCMA) and has served as a member of the ICC Commission on Arbitration in Paris, Vice Chairman of the ICC Court's India Arbitration Group, Legal Consultant at Shardul Amarchand Mangaldas, and Director at the Faculty of Law, Manav Rachna University. He currently serves as India's National Correspondent to the UNCITRAL CLOUT system.

Objective of the Course

This course is designed to strengthen India's capabilities in international arbitration by offering participants a thorough understanding of international commercial and investment treaty arbitration, along with the practical skills required to handle complex cross-border disputes in a globalised economic environment. This assumes particular significance at a time when the global transition to green energy and emerging technologies is giving rise to complex, cross-border disputes. As India's integration with international markets continues to deepen and as the country advances its own transition towards sustainable energy and technological innovation, a strong understanding of the legal frameworks governing disputes has become increasingly essential.

Outline of the Course

Building on the success of the previous edition, this year's course is designed as a structured programme with a strong emphasis on practical and contemporary issues in international arbitration. It will be delivered through a combination of lectures and interactive sessions led by eminent academics and experienced practitioners in the fields of international commercial and investment treaty arbitration.

The course will run for a duration of five months and will be divided into two parts:

Part A – International Commercial Arbitration: This module focuses on providing both conceptual understanding and practical insight into the resolution of cross-border commercial disputes.

Part B – Investment Treaty Arbitration: This module examines the legal framework governing Bilateral Investment Treaties (BITs) and explores dispute resolution mechanisms under international investment law.

Candidates will be assessed through a combination of continuous assessment and an end-term examination.



Details of the Course

Eligibility and Prerequisites:

- Open to only Government officials (working in any Government Department/PSU), lawyers, academicians, and law officers (PSU/ Private employment).
- Candidate must have completed his/her graduation, in any discipline, with a minimum of 50 % marks.

Attendance: minimum attendance of 75% required for completion of the course.

Fee details: Rs. 1.10 lakhs

The course will be delivered in a hybrid format, with select sessions (approximately 30%) as mandatory inperson engagements. The rest (approximately 70%) will be in online mode. The course will be delivered by a distinguished faculty comprising leading international and national practitioners, alongside eminent academics in the field of arbitration.

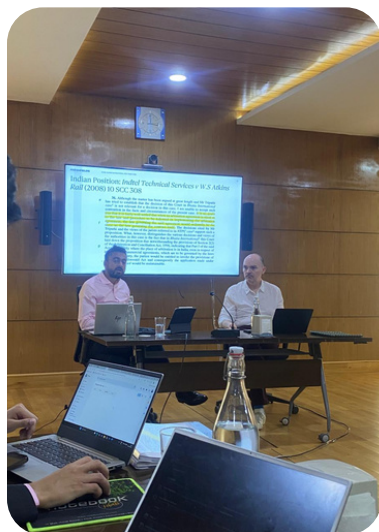

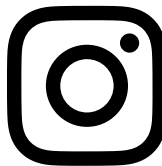
