About the Opportunity

National Law University Delhi (NLUD) invites applications for the position of Full-time Research Associate on a contractual basis for a project on Reparations and Victim-Centred Justice under International Criminal Law. The project is funded under the Research Endeavour Grant (N-REG) 2025-26 of National Law University Delhi and focuses on evaluating reparations jurisprudence within international criminal law. The appointment is initially for a six-month period, with the possibility of extension based on performance and project requirements.

Responsibilities

The candidate will be expected to assist in the research work in the relevant area of international criminal law in consultation with the Project Director.

Eligibility

- Law graduate (LL.B. or B.A.LL.B.) and LL.M. (appearing/completed) from a recognized Indian or Foreign University with a good academic record.
- At least one peer reviewed publication in quality journal. Previous experience in working on international law related research projects is desirable.
- Knowledge of substantive and procedural international law.
- Proficiency in English.
- Skilled in MS Office applications.

Remuneration: Rs. 35,000/- p.m. consolidated. The salary will be funded out of the grants received from the N-REG project directly by National Law University Delhi.
