Uppsala University, founded in 1477 by papal bull from Pope Sixtus IV at the initiative of Archbishop Jakob Ulvsson, stands as Sweden's oldest university and the Nordic region's first. It briefly suspended operations around 1515 amid religious conflicts but resumed in 1593, expanding rapidly after King Gustavus Adolphus's major endowments in the 1620s, which boosted student numbers and subjects beyond theology, law, and philosophy.

Today, Uppsala ranks among the world's elite research universities, placing 88th in ARWU (Shanghai) 2024, 93rd in QS 2026, 130th in Times Higher Education 2025, and 150th in US News 2024–2025. These positions reflect its leadership in international research networks, where it helps Sweden rank third globally.

As one of Sweden's most internationally renowned institutions, Uppsala drives world-class education and scholarship to solve global challenges, from life sciences at its Biomedical Centre to historic collections like the Linnaeus botanical gardens and Gustavianum museum. Notable alumni and faculty include Carl Linnaeus, Anders Celsius, and eight Nobel laureates.
